No worries at all, I figured you were buried and would get to me when you could. I really appreciate your continued support despite a workload that I know is extremely intense for you. Please don't hesitate to let me know if I can do anything to assist you as well.

I would appreciate an opportunity to sync up with you prior to the full committee meeting, for two reasons. First, to determine if there is anything you'd like to specifically see addressed and second, to let you know what information I have to share so if you have thoughts on how we approach or direction we go on the call, we can incorporate. However, I know how pressed your schedule is, so let me share my thoughts and as always, I welcome and appreciate yours in return.

Thought we might start by taking a quick look at the Charter (attached here) so that the three new members could acquaint themselves, and the committee could review to see if any changes are suggested/necessary. Next, the same kind of "quick review" of the guiding principles (also attached). Figured 5-10 minutes on each? Then perhaps spend the bulk of the discussion on the list of business opportunities (attached as well, and has not been updated since Feb 2008). I can provide updates on all of the priority 1 items as they've all been heavily worked over the last year (and could do so by providing an April 2009 version of this document, containing bullet points on status). As to the rest of the list, we had a meeting this past week with Senior staff and discussed the list and business opportunities in general, and I'd like to share our thoughts, but more importantly capture the thoughts/input/direction from the Committee. Then we can round out the call with decisions, the Committee's recommendations to the Board and/or any action items. After the meeting, I will draft a report for your review and edits, and then you will be prepared to give the BOC report at the May Board meeting.

Please keep in mind that these are suggestions only, and I remain completely open to suggestions from you and/or the Committee. If you'd like to further discuss, let me know when you will have time (not restricted to Mon-Fri, 9-5) and I'll make myself available. Otherwise, feel free to respond via email if that works better for you.

Hope you get some down time this weekend and thanks again, Marcia, I really do appreciate the extra time I know this takes and am grateful for your support.
