**The State:** Garners Ferry reopens; almost 100 Richland roads remain closed

Traffic flowed once again on Garners Ferry Road Thursday, more than a week after it was submerged in historic floods. Part of Columbia's North Main Street, near Elmwood Park, also reopened. But it could be Thanksgiving or later before the state knows how much it will cost to repair its roads and bridges, acting S. C. Transportation Department chief Christy Hall said Thursday.

The Legislature will petition the state Supreme Court on Monday to reexamine the court's deadline for a plan to help struggling rural schools. According to House Speaker Jay Lucas' office, the petition will deal with the most recent court order from a landmark education case over unequal funding, something states across the country have faced.

**Note:** The courts already rejected one attempt in December by Gov. Nikki Haley, Senate President Pro Tempore Sen. Hugh Leatherman and Lucas to rehear the case.

**Note:** Neither the Attorney General's Office nor Haley's have said if they plan to file by the deadline, which was moved from Thursday to Monday due to recent flooding.

After years of negative audit reports, huge deficits and low credit ratings, South Carolina State University showed a "substantial trend" toward improvement in 2014-15, according to its external auditor. Stathis Poulos of BDO LLC told trustees on Thursday that the university's operating deficit dropped by 60 percent in fiscal year 2015, down from \$10 million to \$4 million.
