**STOP H.R. 2646, 'Helping Families in Mental Health Crisis Act' PLOT  
Against Liberty, Privacy and The Constitution**

**Pass H.R. 1980 The National Reciprocity Concealed Carry Act  
Reject Illegal Obama Executive Orders, Actions, Fiats**

Whereas the Founders of America believed that our Constitution's Second Amendment protections of INDIVIDUAL LIBERTY were vital to the preservation of freedom, and

Whereas Obama and colluding RINO politicians in pursuit of their gun control agenda seek to exploit tragedy from random acts of violence by madmen, are cynically promoting firearms confiscation through intrusive, exploitative legislation and disproportionate, unaffordable Federal regulation and taxes, like the unconstitutional and odious H.R. 4269, the Assault Weapons Ban of 2016 and the "Reducing Gun Violence In Our Neighborhoods Act" now propose H.R. 2646, the "Helping Families in Mental Health Crisis Act," which grossly violates medical privacy rights of even children and targets those with learning challenges with forfeiture of their right to bear arms! I DEMAND this repulsive bill be BURIED!

NOW THEREFORE, we the undersigned do declare our support for the Second Amendment that shall not be infringed, no matter in what local, State or Federal jurisdiction we may travel. We call for repeal of unlawful ordinances, nullification of illicit Executive fiats and DEMAND instead your support for and enactment of H.R. 131, the Interstate Transportation of Firearms and Ammunition Act.

We specifically REJECT Obama's edicts, fiats, directives, and "Executive Orders" of ILLEGAL, UNCONSTITUTIONAL nationwide gun control, and demand YOUR support for the NEW "Second Amendment Protection Act of 2016" and reintroduction and enactment of S. 1908, the National Carry Reciprocity Act, to secure the Second Amendment rights of every law abiding citizen NOT SUBJECT to the whims and jurisprudence of State lines -- or partisan politicians! We demand you reject any gun control legislation SURRENDER, fake "mental health reform" like H.R. 2646, or anything else -- defend MY protected Second Amendment rights NOW!

We do demand our State Governors respect the Constitution, litigate in 2nd Amendment defense, and VETO or LEAD FOR REPEAL any legislation that infringes our right to arms -- such as that recently passed in New Jersey, Connecticut, New York, Vermont and Colorado.
