New Blog: Pilots in Colorado and Western Australia Integrate Paramedics into Care Team

In her [latest blog](#) from Australia, Mary Takach looks at primary health care organizations (PHCO) working to reduce unnecessary emergency department (ED) visits. Reducing inappropriate utilization of the ED is a very common focus of health systems, payers, and practices seeking to improve health care quality and reduce costs. To help break the cycle of non-emergency ED use, lists of “superutilizers” are generated from a variety of data sources and care managers are assigned to work with these patients. In my [fellowship research project](#) that is comparing publicly funded PHCO in the U.S. and Australia, I have come across two PHCOs, one from each country, that are working with their local fire departments or ambulance services to capitalize on the skills

of paramedics to deter non-emergency transports.

Many states across the nation are in the process of designing and implementing multi-payer payment reform initiatives. The goals of these initiatives are to improve patient experience, improve the health of populations, and reduce health care costs.
