Public Servant of the Year

Governor Nikki Haley

Nikki Randhawa Haley was re-elected as the 116th Governor of South Carolina in 2014 by the largest margin of victory for a South Carolina gubernatorial candidate in 24 years. During her first term, Governor Haley, the first female and the first minority governor in South Carolina history and currently the youngest governor in the country, delivered results to the people of every part of our state. Under the governor's leadership, South Carolina's jobless rate hit record lows, the state announced more than 70,000 jobs in 45 of 46 counties, more than 25,000 South Carolinians moved from welfare to work, and the state made its largest infrastructure investment in a generation without raising taxes.

Business Leader of the Year

Kevin Marsh, Chairman & CEO of SCANA

Kevin Marsh joined South Carolina Electric & Gas Company (SCE&G), the principal subsidiary of SCANA Corporation, in 1984 as group manager of technical accounting and was named vice president and controller in 1989. Since then he has served in the capacity of vice president of corporate planning of SCE&G and vice president of finance, treasurer and controller of SCANA Corporation. In 1996, Marsh was named vice president and chief financial officer (CFO) of SCANA and became senior vice president in 1998. In addition to his duties as SCANA's CFO, from October 2001 to March 2003, he served as president and chief operating officer of PSNC Energy, the company's natural gas distribution company headquartered in Gastonia, North Carolina. He became president of SCE&G in 2006 and became president and chief operating officer (COO) of SCANA Corporation in January 2011. He assumed responsibilities as chairman and CEO in December 2011. Prior to his career at SCANA he worked at Deloitte & Touche Certified Public Accountants in Columbia, South Carolina for seven years. Marsh serves on the board of Epworth Children's Home, Citizens for Sound Conservation, the Institute of Nuclear Power Operations (INPO), the Nuclear Energy Institute (NEI) and the Edison Electric Institute (EEI). He is a past board member of First Citizens Bancorporation of South Carolina, Palmetto Place Children's Emergency Shelter, Junior Achievement of South Carolina, and Sharing God's Love emergency support

organization.

Business Leader of the Year

Lonnie Carter, President & CEO of Santee Cooper

Lonnie N. Carter is President and Chief Executive Officer of Santee Cooper, South Carolina's state-owned electric utility. The Santee Cooper Board of Directors named Carter the company's eighth Chief Executive Officer on January 26, 2004. He joined Santee Cooper in 1982 as an employee in the controller's office. In 1997, on loan from Santee Cooper, Lonnie was instrumental in founding and served as the first President and Chief Executive Officer of The Energy Authority. Based in Jacksonville, Florida, TEA is a joint power marketing organization comprised of publicly owned utilities. Carter serves on the boards of Palmetto Economic Development Corporation, Charleston Regional Development Alliance Economic Leadership Council, Trident CEO Council, Trident United Way, Trident Technical College Foundation, The Energy Authority and Colectric Partners Inc. He is Chairman of the Charleston Regional Development Alliance and Past Chairman of the Large Public Power Council and American Public Power Association. He serves on advisory boards for The Citadel School of Business, the University of South Carolina School of Engineering and the Clemson University Presidential Advisory Board.

Sgt. William Jasper Freedom Award

D. Murray Price, 1st Lieutenant, U.S. Army Air Corps, WWII

D. Murray Price is a Lexington County native who, when he answered the call of duty in WWII, had never been out of his hometown but twice. Price, who at the age of 94 is now one of South Carolina's oldest living war heroes, was also a businessman, having retired as the president of Pearce-Young-Angel Company, the Southern Division of PYA/Monarch, Inc. (currently known as US Foodservice). 1st Lt. Price gave more than the average airman in the U.S. Army Air Corps. He flew 40 missions in a B-24 throughout the South Pacific and was awarded the Distinguished Flying Cross and the Air Medal with six Oak Leaf Clusters. After the war, Price took up the mantle of community service serving on the boards of banks, colleges, hospitals, chambers of commerce, arts associations, and churches. The Columbia YMCA was his main interest for much of his life, raising money and donating 20 acres of land to the camp. As a longtime ambassador for Lexington, Price has dedicated his life to serving others.
