Times and Democrat: 26 new jobs coming; 200 could follow

Santa arrived two days early for Orangeburg County in the form of two industrial announcements that could bring a total investment of \$27.5 million and 226 new jobs over the next five years. Quality Model South Carolina Inc. announced Monday it plans to invest \$3 million into a new product line at its facility in the Orangeburg County/City Industrial Park. It will add 26 new jobs. In addition, Orangeburg County Council approved incentives for a company which officials are only calling "Project Compute" for now.

Note: "We are thrilled another international company is expanding in our state," Gov. Nikki Haley said. "We applaud Quality Model for continuing to grow their business in Orangeburg County, investing \$3 million and creating 26 new jobs."

Greenville News: Plan would provide funds to repair roads

Six months after state lawmakers approved funding to leverage more than \$600 million for road and bridge repairs, a senator said he will introduce amendments to a pending bill that could amount to \$900 million more for the state's crumbling infrastructure. Sen. Ray Cleary, a Georgetown County Republican who championed road funding earlier this year in the Senate, told The Greenville News that he has prepared 17 amendments to a House bill on the Senate calendar that include raising fees and fee-like taxes such as the state's sales tax on cars, increases in driver's license fees and vehicle registration and indexing the state's gas tax for inflation.

Note: It doesn't include any bonding proposal, which he said "doesn't solve the problem," and doesn't contain, he believes, any tax increase, which might allow Gov. Nikki Haley to sign the bill or at least not oppose it.

A legislative panel on Monday dismissed allegations that Rep. Bill Chumley inappropriately used state aircraft when he shuttled a conservative commentator from the Washington area to testify on his bill. The House Ethics Committee voted unanimously after hearing from Chumley and his attorney for more than an hour. Following closed-door deliberations, the panel found insufficient proof that Chumley knowingly violated state law or economically benefited from the trip. "I think justice was served," Chumley, R-Woodruff, said after the vote. "It's the right thing to do. I think the committee was extremely fair."

The House Ethics Committee said earlier this year it was not "an appropriate use of taxpayer dollars and resources" to use a state-owned airplane to fly witnesses to Columbia to testify about bills before the Legislature. But Monday, the committee unanimously dismissed a complaint against state Rep. Bill Chumley, who used a state plane to fly conservative commentator and economist Walter Williams to Columbia from Washington to testify in favor of a bill that would nullify the federal Affordable Care Act. State Rep. Kenny Bingham, R-Lexington, said the committee's earlier stance — issued in the form of an advisory opinion — was "inartfully drafted" and likely will be revisited.

Boeing could more than double its Dreamliner production and nearly triple the building space it occupies now in North Charleston, according to a regulatory filing to offset the loss of wetlands as the airplane-maker expands. The Chicago-based aerospace giant provides a glimpse of what it intends to do with the nearly 500 acres it recently leased beside Charleston International Airport in a wetlands mitigation plan filed through the Army Corps of Engineers and the S.C. Department of Health and Environmental Control.

South Carolina's first solar farm is complete and producing energy from a site in Colleton County, three

months after state utility interests announced their initial foray into larger-scale sun-powered projects. The plant went on line for commercial use Friday, marking what solar energy proponents say is a milestone for South Carolina. Utilities in the Palmetto State have been reluctant to embrace solar energy, saying it is a less reliable power source than other energy forms – despite growing interest nationally in solar's economic and environmental benefits.

The Duke Endowment will invest \$1.4 million in the Medical University of South Carolina's emerging telemedicine-ICU program this month. This is particularly good news considering MUSC administrators worried this fall that the institution may be ineligible for grant money from the endowment with no permanent president at the helm. Historically, the Duke Endowment has not awarded new grants to organizations in between leaders, said Jim Fisher, vice president for development and alumni affairs, during the MUSC Board of Trustees' October meeting.

Southern politicians and energy industry groups are increasing the push to allow drilling off the U.S. Atlantic Coast for oil and gas deposits that could be puny or mean big cash to a part of the country where it's now largely absent. Although drilling, refineries and the jobs that could accompany them are at least a decade away, the Obama Administration is weighing a decision expected to be announced in the next three months on whether to take an important early step: to allow seismic testing of the sea bottom. The tests could firm up estimates of how much hydrocarbon deposits may be out there.

A convicted sex offender who fled Rhode Island has been found working at a hotel in Columbia, S.C. The Providence Journal reports (<http://bit.ly/1gE23RO>) that Luis Ortiz was convicted in 2000 of sexually assaulting a 16-year-old girl in Pawtucket and was sentenced to 10 years, with 42 months in prison. When he was released he was to have registered as a sex offender but failed to do so. Deputy C.J. Wyant, who leads the U.S. Marshals Service's sex offender task force in Providence, says the 40-year-old Ortiz was arrested in January for failing to register as a sex offender. Wyant says he disappeared when he was released on bail.

A Canadian company is expanding its operations in Orangeburg, adding 26 jobs. Quality Model is a plastic injection modeling company that plans to spend about \$3 million in the expansion. The company serves the power sports, industrial, automotive and lawn and garden industries.

The City of Aiken has resumed the release of incident reports involving juvenile defendants to the public, according to City Manager Richard Pearce, reversing a suspension of those releases announced last week. Despite that dramatic turn of events, questions remain about the City's ongoing compliance with state law. Although the City says it has now "returned" to the prior policy of routinely releasing such documents, it has yet to verify the report involving a September sex crime at Aiken Middle School was actually handled in that manner.

Colleton County sheriff's officials say a 17-year-old shot and wounded by a deputy had pointed a gun at the officer. Officials say the deputy had tried to pull over the teen shortly after 2 a.m. Sunday for making an improper turn. A sheriff's report says the driver did not stop and the deputy chased the suspect. Officials say Kareem T. Risher of Smoaks pointed a gun at the deputy after stopping and running from the car. The deputy fired three times, hitting Risher in the buttocks. He was taken to the Medical University of South Carolina in Charleston for treatment. He was listed in stable condition.

Listen carefully when Republicans say they can blame almost every House Democrat for the flaws of the health care overhaul. Rep. Mike McIntyre, D-N.C., is the exception. He's never voted in favor of President Barack Obama's signature health care law. It's a key reason the nine-term Democrat is still in Congress. It might be enough in 2014, although he barely won last year. In a district redrawn by Republicans for Republicans, McIntyre is the GOP's top Democratic target in the battle for control of the House. Instead of Obama at the top of the ticket as he was in 2012, the state's marquee race next year is Democratic Sen. Kay Hagan's battle for re-election.

National Security Agency leaker Edward Snowden said his "mission's already accomplished" after leaking NSA secrets that have caused a reassessment of U.S. surveillance policies. Snowden told The Washington Post in an interview published online Monday night that he was satisfied because journalists have been able to tell the story of the government's collection of bulk Internet and phone records, an activity that has grown dramatically in the decade since the Sept. 11, 2001, terrorist attacks. "For me, in terms of personal satisfaction, the mission's already accomplished," he said. "I already won."
