Over a year ago (May 11, 2007) you conducted a hearing at the Columbia, SC federal courthouse concerning our oldest son Stephen H. Rosenberg's simple and valid request to re-instate his first lawsuit against some South Carolina residents/officials (Stephen H. Rosenberg v. South Carolina County et. Al Civil Action No.: 0:02-2867-10BD). You stated at the end of the three (3) hour plus long hearing in response to my son Stephen's question to you if he would receive a court order from you that "Yes, I will enter an order after today." Even though it has been almost thirteen (13) months, to date you have not made a decision. You have not even had the courtesy to respond to my March 22, 2008 letter (copy of my letter enclosed) or emails from our two other sons who attended the hearing.

I am sorry to state that I feel that you are afraid of backlash from some other officials in your state of South Carolina if you make a ruling in favor of our son Stephen who not only lost everything he owned in South Carolina but also was kept in jail by South Carolina officials with no bond and no trial for almost thirty-seven (37) months on false charges. We are all very, very disappointed in your failure to keep your word that you would make a decision. I can not but feel that "they" got to you and you are afraid to help our son Stephen with problems with officials in your state of South Carolina. I'm appalled that such conditions still exist in South Carolina.

Again, our family would appreciate if you would make this ruling. We all feel that ample time has elapsed. We would also greatly appreciate your assistance in obtaining an official letter from a State of South Carolina judge stating, as we have been told several time, that all of the false and vindictive charges filed in South Carolina against Stephen have been dismissed. No official in South Carolina has responded to any of Stephen's requests that they provide him with a letter stating all charges against him have been dismissed as you recommended Stephen do at the hearing.

I want to bring to your attention and request your immediate intervention regarding a serious case of corruption, cover-up and misconduct in the state of South Carolina. The Beaufort County Sheriff's Dept. including Sheriff P. J. Tanner, Officer Townsend and Officer Norberg have conspired to frame and then silence an innocent person -- my brother, Stephen H. Rosenberg. It is the most obvious and worse case of small-town, good-ole-boy corruption I've ever witnessed.

On December 25, 2000, Hilton Head, S. C. resident Mr. Frank Watson's station wagon was involved in a hit-and-run accident in Beaufort County. Upon arriving at the scene, the Beaufort County Sheriff's Dept. determined that Mr. Watson did own the vehicle by running a DMV check and reported it accordingly. However in order to avoid prosecution, Mr. Watson convinced his long-time friends at the sheriff's office to falsely report that the vehicle belonged to Stephen H. Rosenberg. Despite the DMV records, their initial report, the vehicle title and insurance card, the Beaufort County Sheriff's Dept. knowingly and willingly participated in this fraud. Additionally, as retribution for Mr. Rosenberg's threats to expose them, they fabricated charges, issued a warrant for his arrest and eventually arrested him to keep him quiet. He's currently in jail at the Beaufort County Detention Center. He's been there for over 18 months without bail and without a trial!

All indicating that what I say above is TRUE. Additionally, I've attached a letter previously sent to the Governor of S.C. from Mr. Daniel Turner indicating his assessment of the situation and support of the above charges as well.

Despite hundreds of letters and phone calls by myself and others, Beaufort County officials continue to ignore us and act above the law. No one in South Carolina has the courage or desire to break-up the good-ole boy network of corruption. Therefore, I urgently ask for your assistance in bringing these corrupt officials to justice.
