Below are directions to the Columbia Conference Center. There are no special parking instructions.

Heading EAST on 1-26 (coming from the Upstate)

- Take exit 104 (Piney Grove Rd)
- Turn LEFT onto Piney Grove Rd. Continue for .30 mi.
- Turn RIGHT onto Fernandina Rd. Continue for .90 mi.
- Turn LEFT onto Laurelhurst Avenue.
- The Columbia Conference Center will be on the right.

Heading WEST on 1-26 (coming from the LowCountry)

- Take exit 106B (St. Andrews Rd)
- Turn LEFT onto Burning Tree Dr. Continue for 381ft.
- Continue, crossing over St. Andrews road, Burning Tree Rd will become Fernandina Rd. Follow for 1.3 mi
- Turn RIGHT onto Laurelhurst Avenue.
- The Columbia Conference Center will be on the right.

Heading WEST on 1-20 (coming from 1-95 corridor through Camden)

- Take exit 64B onto 1-26 WEST
- Take exit 106B (St. Andrews Rd)
- Turn LEFT onto Burning Tree Dr. Continue for 381ft.
- Continue, crossing over St. Andrews road, Burning Tree Rd will become Fernandina Rd. Follow for 1.3 mi
- Turn RIGHT onto Laurelhurst Avenue.
- The Columbia Conference Center will be on the right.

Heading SOUTH on 1-77

- Take exit 18 (SC 277 South to 1-20 west- Columbia Augusta)
- Take exit 106B (St. Andrews Rd)
- Turn LEFT onto Burning Tree Dr. Continue for 381ft.
- Continue, crossing over St. Andrews road, Burning Tree Rd will become Fernandina Rd. Follow for 1.3 mi
- Turn RIGHT onto Laurelhurst Avenue.
- The Columbia Conference Center will be on the right.
