### Governor Nikki Haley News:

**Greenville News:** 2AM Group investment forecast to create 100 new jobs in Richland County

A Spartanburg-based company that supplies logistics, manufacturing and quality services to the automotive, aerospace and marine industries is creating a new production facility in Richland County, the governor's office announced this morning. 2AM's Blythewood facility will be the company's 11th overall location and the fifth in the state. Operations at the new facility, located at 110 Belk Court in Blythewood, began mid-August.

**Note:** 2AM Group is investing \$500,000 in the facility and will generate 100 new jobs over the next three years, according to Gov. Nikki Haley's office.

**Note:** Since January 2011, South Carolina has recruited more than \$9 billion in capital investment and more than 26,000 jobs in the manufacturing sector, Haley's office says.

**The State:** Same-sex Marriage Suit: Haley Likely To Defend SC Marriage Law

Gov. Nikki Haley likely will mount a defense in federal court against a challenge by two Lexington County women to the state's 1996 Defense of Marriage Law and a section of the State Constitution that bans gay marriages in South Carolina. A spokesman for state Attorney General Alan Wilson – the other defendant named in a just-filed potentially historic lawsuit challenging state bans on gay and lesbian marriage – said Tuesday that Wilson has no immediate comment.

**Note:** "Gov. Haley, like the majority of South Carolinians, supports traditional marriage as defined between one man and one woman, and in accordance with state law, will continue to uphold those values. The legislature has spoken on this issue, the people have spoken on this issue, and the governor remains resolute in her support of South Carolina's Constitution and state's rights and this lawsuit doesn't change that," said Haley spokesman Doug Mayer in an email Tuesday.

The Medical University of South Carolina is getting the chance to try out a new way of providing health care for its employees, in an experiment that could pave the way for changes for all state employees. On Tuesday, the Budget and Control Board approved the school's proposal for a one-year pilot program, which would create a "patient-centered medical home" for the university's 18,000 employees. Workers and their families would get health care through a more centralized system, with case managers helping ensure they get the most effective, efficient care. Employees would be able to pick from MUSC's primary care doctors, all of whom have been certified to provide that level of care, according to MUSC chief executive officer Pat Cawley.

**Note:** "Primary care is very important. Preventative care is very important," Gov. Nikki Haley, who chairs the Budget and Control Board, said. "If you focus in on those two, it should be very effective."

**Associated Press:** OK Supreme Court issues stay in custody case

The Oklahoma Supreme Court has granted an emergency stay to keep a 3-year-old Cherokee girl with her biological father and plans to hear arguments from his lawyers and those of the girl's adoptive parents later Tuesday. The court granted the stay Friday, although it only became public on the court's website Tuesday. Three-year-old Veronica's birth mother was pregnant when she put the girl up for adoption. A South Carolina couple, Matt and Melanie Capobianco, have been trying to adopt Veronica since she was born, while her biological father, Dusten Brown, has been fighting them for custody.

An adoption fight centered around a 3-year-old Cherokee girl is entering another phase with arguments set before Oklahoma's highest court. Dusten Brown of the Cherokee Nation says the Indian Child Welfare Act dictates his daughter should remain with him, but the U.S. Supreme Court has said the act doesn't apply in this case. Matt and Melanie Capobianco of Charleston, S.C., have tried adopt the girl since she was born. Veronica's mother agreed to the adoption but Brown has since intervened. Parties gathered Tuesday at the Oklahoma Supreme Court with state troopers standing by. Justices have granted an emergency stay to keep Veronica with Brown. A state Supreme Court referee is expected to recommend which court should take the case next: South Carolina's, Oklahoma's or the Cherokee Nation's.

A court order for Matt and Melanie Capobianco to immediately get custody of Veronica, the girl they adopted, was halted by the Oklahoma Supreme Court, according to records made available this morning. Attorneys for the girl's birth father who has been caring for her for the past 19 months, Dusten Brown, were granted the stay of judgment on Friday. That's the day attorneys for both sides met in a courtroom in Nowata County, where Brown lives. It had been thought that the Nowata court ordered Brown to immediately transfer custody to the James Island couple, but the Oklahoma's high court hadn't confirmed that until it posted the records this morning. The stay stopped the custody change from happening.

U.S. Sen. Lindsey Graham said Tuesday that while South Carolinians and the nation are weary of war, the United States must make an effective strike in response to Syrian President Bashar Assad's use of chemical weapons against his own people. "I don't want an open-ended, unlimited military campaign," the Republican lawmaker told reporters before speaking to a chamber of commerce group. "I'm not supporting a 'check the box strike.' I want a strike that will degrade Assad's ability to deliver chemical weapons and change the tide of battle." Graham and Arizona Sen. John McCain met with President Barack Obama on Monday and won conditional support from him for an attack. Graham said Tuesday the president must lay out a clear case to Congress.

U.S. Sen. Lindsey Graham said today his job is to convince Americans that the future of Syria will affect their national security. Fresh off his Monday meeting with President Obama and fellow Sen. John McCain over Syria's recent use of chemical weapons, Graham talked to Berkeley County business leaders at a luncheon. "I'm tired of war as much as anybody," he said. "Syria doesn't have to be like Iraq or Afghanistan, but if it's left unaddressed, it's going to be a nightmare for us." Graham and McCain, considered among Obama's most hawkish critics, met with the president this weekend, as Obama tries to convince Congress to approve his plans to strike at Syria.

Sen. Lindsey Graham (R-S.C.) told Right Turn in a phone conversation this morning, "I'm not going to support a strategy that has zero chance of success." Contrary to news reports, he told me that he and Sen. John McCain (R-Ariz.) aren't yet sold on President Obama's strategy for Syria. Without them, Graham said bluntly, there is little chance of a "yes" vote from Congress. "I don't know if we can carry [the yes vote] over the finish line but I can assure defeat without us." Graham is realistic about our current options. "This is not a yes or no question. It's about bad and worse," he observed. "Good and very good are in the rear view mirror." Nevertheless, he warned, "I've got to be convinced there is a strategy." Right now, the jury is out. For the first time I can recall, he said a hapless effort with no chance of success is "just as bad" as a "no" vote.

**Greenville News:** GOP primary election lawsuit dismissed

A federal judge has dismissed a lawsuit by the Greenville County Republican Party's executive committee that hoped to block Democrats from voting in GOP primary elections. The county GOP had filed a constitutional challenge in federal court to various South Carolina election statutes. U.S. District Judge Mary G. Lewis ruled, however, the party didn't have legal standing to sue to close South Carolina primaries, court records show. In South Carolina, any registered voter is allowed to participate in a primary election without declaring a political affiliation.

A former Secret Service agent has been sentenced to five years in prison for plotting to kidnap a retired judge. A judge handed down the sentence Tuesday after an Oconee County jury found James Bartee guilty of solicitation to commit a felony. Bartee was also sentenced to five years of probation. Bartee was arrested during a May 2012 hearing while he was running for Oconee County sheriff. Authorities said he was worried a hearing would reveal he didn't have the qualifications to be sheriff and paid an informant to kidnap a former judge who was going to testify against him.

The feral hog isn't about to go away. The population will continue to grow — whether or not they are hunted and trapped. Problems like the recent homeowners' damage in West Ashley can be expected to get worse. Land managers and others worry about eventually having to deal with a Texas-size problem. The 2 million-or-more hog population in that state is considered to be 10 times larger than it was 30 years ago, according to the Houston Chronicle, even though the state virtually declared war on them 20 years ago with some of the most aggressive "taking" policies in the nation, and hundreds of thousands of the animals are killed each year.

**Associated Press:** Obama gains Boehner's support for Syria strike

President Barack Obama won critical support from House Speaker John Boehner for a punitive strike against Syria on Tuesday, and senior Cabinet officials labored to convince Congress that Bashar Assad's government must be punished for a suspected chemical weapons attack the administration blames for more than 1,000 dead. The leader of House Republicans, Boehner emerged from a meeting at the White House and said the United States has "enemies around the world that need to understand that we're not going to tolerate this type of behavior. We also have allies around the world and allies in the region who also need to know that America will be there and stand up when it's necessary." Boehner spoke as lawmakers in both parties readied changes in the president's requested legislation, rewriting it to restrict the type and duration of any military action that would be authorized, possibly including a ban on U.S. combat forces on the ground.
