NELLIE HUGHES IS 79 YEARS OLD, LEGALLY BLIND, WALKS WITH A WALKER AND WEIGHS 73 POUNDS. HER ROOF IS LEAKING AND HER CEILING IS FALLING IN SEVERAL PLACES. SHE LIVES ON \$935. PER MONTH NO OTHER INCOME. HER MORTGAGE PMT HAS BEEN \$983 PER MONTH FOR YEARS AND SHE WAS ONLY ABLE TO MAKE IT WITH HELP FROM FRIENDS AND SOME CHURCHES AROUND THE AREA. THAT FRIEND HAS DIED.

HER MORTGAGE PMT IS IN A TRIAL PHASE AND HAS BEEN REDUCED TO 209 PER MONTH TEMPORARY. SHE HAD BEEN GETTING \$200 PER MONTH IN FOOD STAMPS AND THEY WERE CUT TO 34 DOLLARS. THAT WILL NOT EVEN BUY MILK AND BREAD FOR A MONTH. SHE STILL HAS ALL OF HER REGULAR BILLS. SHE NEEDS THE FOOD STAMPS TO INSURE THAT SHE HAS ENOUGH TO EAT.

SHE CANNOT AFFORD TO HAVE HER ROOF REPLACED OR HER CEILING REPAIRED SHE HAS NO MONEY.

HOW CAN THIS STATE AND COUNTRY KEEP SUPPORTING ILLEGAL IMMIGRANTS AND REFUSE TO HELP PEOPLE LIKE NELLIE HUGHES?

SHE NEEDS HELP NOW HER FOOD STAMPS NEED TO BE PUT BACK TO THE 200 DOLLARS AND HER ROOF NEEDS TO BE REPLACED. WHY WON'T SHE GET HELP?

PLEASE RESPOND TO THIS AND LET ME KNOW WHAT IF ANYTHING WILL BE DONE WITH THIS.
