## PROHIBIT HARMFUL ELECTRONIC OR ELECTROMAGNETIC DEVICES

### House Bill 4513

## A SUMMARY OF HOUSE BILLS 4513 AND 4514 AS INTRODUCED 4-2-03

The bills would amend provisions contained in Chapter 33 of the Michigan Penal Code entitled "Explosives and Bombs, and Harmful Devices" to define the term "harmful electronic or electromagnetic device" and to prohibit the manufacture or use of such a device. The bills are tie-barred to each other. Specifically, the bills would do the following:

House Bill 4513 would amend the penal code (MCL 750.200h) to define "harmful electronic or electromagnetic device" as a device designed to emit or radiate an electronic or electromagnetic pulse or signal or microwave intended to cause harm to others or cause damage to, destroy, or disrupt any electronic or telecommunications system or device including a computer or computer network. The bill would also include a harmful electronic or electromagnetic device in the definition of "imitation harmful substance or device." Further, Section 200h currently defines "serious impairment of a body function" as meaning that term as defined by Section 58c of the Michigan Vehicle Code. This definition would be deleted and replaced by the full definition as contained in the vehicle code.

House Bill 4514 would amend the penal code (MCL 750.200i et al.) to make it a crime to manufacture, deliver, possess, transport, place, use, or release a harmful electronic or electromagnetic device for an unlawful purpose. This would be in addition to the current prohibitions for harmful biological substances or devices, harmful chemical substances or devices, and harmful radioactive materials or devices. The penalty would be the same as currently allowed (penalties range from imprisonment for not more than 15 years and a fine of not more than \$10,000, or both to life without parole and a fine up to \$40,000). In addition, the bill would specify that the penalties would apply whether the violation resulted directly or indirectly in property damage or in personal injury, serious impairment, or death to another person.

Similarly, it would also be prohibited to cause an individual to falsely believe that he or she had been exposed to a harmful electronic or electromagnetic device just as it is currently prohibited to do so regarding a harmful biological substance or device, harmful chemical substance or device, or harmful radioactive material or device. The penalty for this crime would remain the same as for the others at imprisonment for not more than five years, a fine of not more than \$10,000, or both.

House Bill 4513 and 4514 (5-19-03)

Lastly, the bill would delete several redundant provisions. For instance, the act requires a court to impose costs on a person who led others to falsely believe that they had been exposed to harmful substances or devices to reimburse a governmental agency for its expenses incurred as a result of the violation. This provision is unnecessary as the Code of Criminal Procedure requires a court, as part of a person's sentence for a conviction of any violation or attempted violation of Chapter 33 of the penal code, to order the person to reimburse any governmental entity for expenses incurred in relation to the incident including, but not limited to, expenses for an emergency response and expenses for prosecuting the person. Also, several sections of Chapter 33 contain definitions of the term "serious impairment of a body function." Since House Bill 4513 would fully define this term in Section 200h, these provisions are unnecessary and repetitive.

## **ENROLLED HOUSE BILL No. 4513**

AN ACT to amend 1931 PA 328, entitled "An act to revise, consolidate, codify and add to the statutes relating to crimes; to define crimes and prescribe the penalties therefor; to provide for restitution under certain circumstances; to provide for the competency of evidence at the trial of persons accused of crime; to provide immunity from prosecution for certain witnesses appearing at such trials; and to repeal certain acts and parts of acts inconsistent with or contravening any of the provisions of this act," by amending section 200h (MCL 750.200h), as amended by 2001 PA 135.

*The People of the State of Michigan enact:*

Sec. 200h. As used in this chapter:

- (a) "Chemical irritant" means solid, liquid, or gas that through its chemical or physical properties, alone or in combination with 1 or more other substances, can be used to produce an irritant effect in humans, animals, or plants.
- (b) "Chemical irritant device" means a device designed or intended to release a chemical irritant.
- (c) "Computer", "computer network", and "computer system" mean those terms as defined in section 145d.
- (d) "Deliver" means that actual or constructive transfer of a substance or device from 1 person to another regardless of any agency relationship.
- (e) "For an unlawful purpose" includes, but is not limited to, having the intent to do any of the following:
  - (i) Frighten, terrorize, intimidate, threaten, harass, injure, or kill any person.
  - (ii) Damage or destroy any real or personal property without the permission of the property owner or, if the property is public property, without the permission of the governmental agency having authority over the property.
- (f) "Harmful biological device" means a device designed or intended to release a harmful biological substance.
- (g) "Harmful biological substance" means a bacteria, virus, or other microorganism or a toxic substance derived from or produced by an organism that can be used to cause death, injury, or disease in humans, animals, or plants.
- (h) "Harmful chemical device" means a device that is designed or intended to release a harmful chemical substance.
- (i) "Harmful chemical substance" means a solid, liquid, or gas that through its chemical or physical properties, alone or in combination with 1 or more other chemical substances, can be used to cause death, injury, or disease in humans, animals, or plants.

(j) "Harmful radioactive material" means material that is radioactive and that can be used to cause death, injury, or disease in humans, animals, or growing plants by its radioactivity.

(k) "Harmful electronic or electromagnetic device" means a device designed to emit or radiate or that, as a result of its design, emits or radiates an electronic or electromagnetic pulse, current, beam, signal, or microwave that is intended to cause harm to others or cause damage to, destroy, or disrupt any electronic or telecommunications system or device, including, but not limited to, a computer, computer network, or computer system.

(l) "Harmful radioactive device" means a device that is designed or intended to release a harmful radioactive material.

(m) "Imitation harmful substance or device" means a substance or device that is designed or intended to represent 1 or more of the following or that is alleged to be 1 of the following but that is not any of the following:

(i) A harmful biological device.

(ii) A harmful biological substance.

(iii) A harmful chemical device.

(iv) A harmful chemical substance.

(v) A harmful radioactive material.

(vi) A radioactive device.

(vii) A harmful electronic or electromagnetic device.

(n) "Serious impairment of a body function" means that term as defined in section 58c of the Michigan vehicle code, 1949 PA 300, MCL 257.58c.

(o) "Telecommunications system" means that term as defined in section 219a.



# Torture Victim Protection Act of 1991

## The Torture Victim Protection Act of 1991 (TVPA; Pub.L. 102–256

(<http://legislink.org/us/pl-102-256>), H.R. 2092

(<https://www.congress.gov/bill/102nd-congress/house-bill/2092>), 106 Stat. 73 (<http://legislink.org/us/stat-106-73>), enacted March 12, 1992) is a statute that allows for the filing of civil suits in the United States against individuals who, acting in an official capacity for any foreign nation, committed torture and/or extrajudicial killing. The statute requires a plaintiff to show exhaustion of local remedies in the location of the crime, to the extent that such remedies are "adequate and available." Plaintiffs may be U.S. citizens or non-U.S. citizens.

Although the Act was not passed until early 1992, it was introduced the previous year, and the official name of the Act is the "Torture Victim Protection Act of 1991."

## Legal issues

In 1992, Sister Dianna Ortiz was the first to file a case under the act, in a civil action against former general and Defense Minister Héctor Gramajo of Guatemala, contending that, by his command authority, he was responsible for her abduction, rape, and torture by military forces in Guatemala in November 1989. A federal court in Massachusetts ruled in her favor, awarding her \$5 million in damages in 1995.<sup>[1]</sup>

#### United States Supreme Court cases

Mohamad v. Palestinian Authority

were awarded a collective sum of almost \$19 million for the pains the men suffered in captivity. see *Daliberti v. Republic of Iraq*, 97 F.Supp.2d 38 (D.D.C. 2000);<sup>[3]</sup> and also *Weinstein v. Islamic Republic of Iran*, 184 F.Supp.2d 13 (D.D.C. 2002). The Foreign Sovereign Immunity Act (FSIA), 28 U.S.C. §§ 1602 (<http://www.law.cornell.edu/uscode/28/1602.html>)–1611 (<http://www.law.cornell.edu/uscode/28/1611.html>),<sup>[4]</sup> prohibits foreign states from being sued in U.S. courts for most non-commercial issues.

The Antiterrorism and Effective Death Penalty Act of 1996 (AEDPA), 28 U.S.C. § 1605 (<http://www.law.cornell.edu/uscode/28/1605.html>)(a)(7), created an exception to the FSIA, allowing U.S. nationals to sue foreign states if the state has been designated as a state sponsor of terrorism and if the plaintiff's injury has been caused by the state's support of a terrorist organization. Following the passage of the AEDPA, numerous suits have been filed against state sponsors of terrorism, particularly Iran. Because some courts have held that the AEDPA does not create a cause of action against foreign states, plaintiffs have used the TVPA and the AEDPA in concert, first using the AEDPA to provide an exception to a foreign state's sovereign immunity, and then using the TVPA to provide a cause of action.<sup>[5]</sup>

The TVPA has also been used by victims of torture by agents of the United States. In *Meshal v. Higgenbotham*, a native-born American citizen alleges U.S. officials repeatedly threatened him with torture, forced disappearance, and other serious harm.

On April 18, 2012, in *Mohamad v. Palestinian Authority*, the United States Supreme Court unanimously ruled that the TVPA applies exclusively to natural persons and does not impose liability against any organizational entity.<sup>[6]</sup> The court's decision was based on the statute's use of the word "individual", as distinguished from "person" (the latter of which is usually defined in U.S. law and statutes as meaning an individual **or** an organization). The court examined the word both in context of its ordinary meaning and through the legislative history of the TVPA. The court noted that the original language of the TVPA bill had used the word "person" and that during a House committee markup, one of the bill's sponsors proposed an amendment "to make it clear we are applying it to individuals and not to corporations."

# Dianna Ortiz

**Dianna Ortiz** (born 1961) is an American Roman Catholic nun of the Ursuline order. While serving as a missionary in Guatemala in 1989, she was abducted on November 2 by members of the Guatemalan military, detained and tortured for 24 hours before being released. After her release, Ortiz reported that an American was among her captors. This has not been confirmed.

Ortiz pursued her case in a Guatemala court and in a United States civil court. In the latter, she was the first to seek civil damages under the Torture Victim Protection Act passed in 1992.<sup>[1]</sup> She filed a case against the Guatemalan Minister of Defense, General Héctor Gramajo, in power at the time of her abduction, arguing that he had command authority. In 1995 she was awarded \$5 million in damages.<sup>[2]</sup> She also filed a case with the Inter-American Commission of Human Rights.

In 1996, as a result of protests by Ortiz and others, as well as revelations of unauthorized CIA funding of the Guatemala military, which had been prohibited by Congress in 1990, President Bill Clinton ordered the release of CIA papers associated with her case, and the declassification of decades of documents related to US relations with Guatemala. These showed that a Guatemala colonel paid by the CIA was implicated in the deaths of the American Michael DeVine in 1990 and guerrilla leader Efraín Bámaca Velásquez in 1993. Congress closed down the CIA program. It also showed decades of United States support of Guatemala during its genocide of its rural indigenous people.

The Center for Constitutional Rights represented Ortiz in her civil case and before the Inter-American Commission of Human Rights, which found in 1997 that the State of Guatemala had violated numerous articles of the American Convention on Human Rights in regard to Ortiz. It recommended that the government complete its long-delayed investigation and that it provide compensation to Ortiz.

# Vertus Hardiman

**Vertus Wellborn Hardiman** (March 9, 1922 – June 1, 2007) was a victim of a US government human radiation experiment at the age of 5 that left him with a painful skull deformity that forced him to cover his head for 80 years.<sup>[1]</sup>

Hardiman was born in Lyles Station, Indiana. In 1928, Vertus attended Lyles Consolidated School where he and nine other children were severely irradiated during a medical experiment conducted at the local county hospital. To get parental consent the experiment was misrepresented as a new therapy for the scalp fungus known as ringworm. The radiation of the skull led to immediate symptoms but also to a severe progressive necrosis of the bone all through his life.

Grossly disfigured, Hardimann bore this injustice with remarkable dignity. In 1945 Vertus traveled to California in search of broader opportunity. In 1946 he worked for the County of Los Angeles General Hospital, where he served with distinction. Vertus lived his last years in Altadena, California. Hardiman died at age 85.

The life of Vertus Hardiman is the subject of a documentary released in 2011 that was written and produced by Wilbert Smith and directed by Brett Leonard.<sup>[2][3]</sup>

**WHEREAS**, the Space Preservation Treaty has established an outer space peacekeeping agency to monitor outer space and enforce the permanent ban of space-based weapons. In addition, this legislation serves as a safeguard for targeted individuals who claim to be under assault from weaponry that should be outlawed by the Space Preservation Act.

**WHEREAS**, the well-being of all residents is of the utmost importance to the City of Richmond.

**NOW THEREFORE BE IT RESOLVED** that the City Council of the City of Richmond hereby supports the Space Preservation Act and companion Space Preservation Treaty, to ensure that individuals will not be targets of space-based weapons

I am asking for your help in stopping these abuses and aiding those already affected.

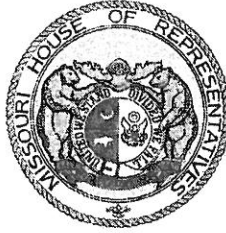

## U.S. Government Harassment - Part 2

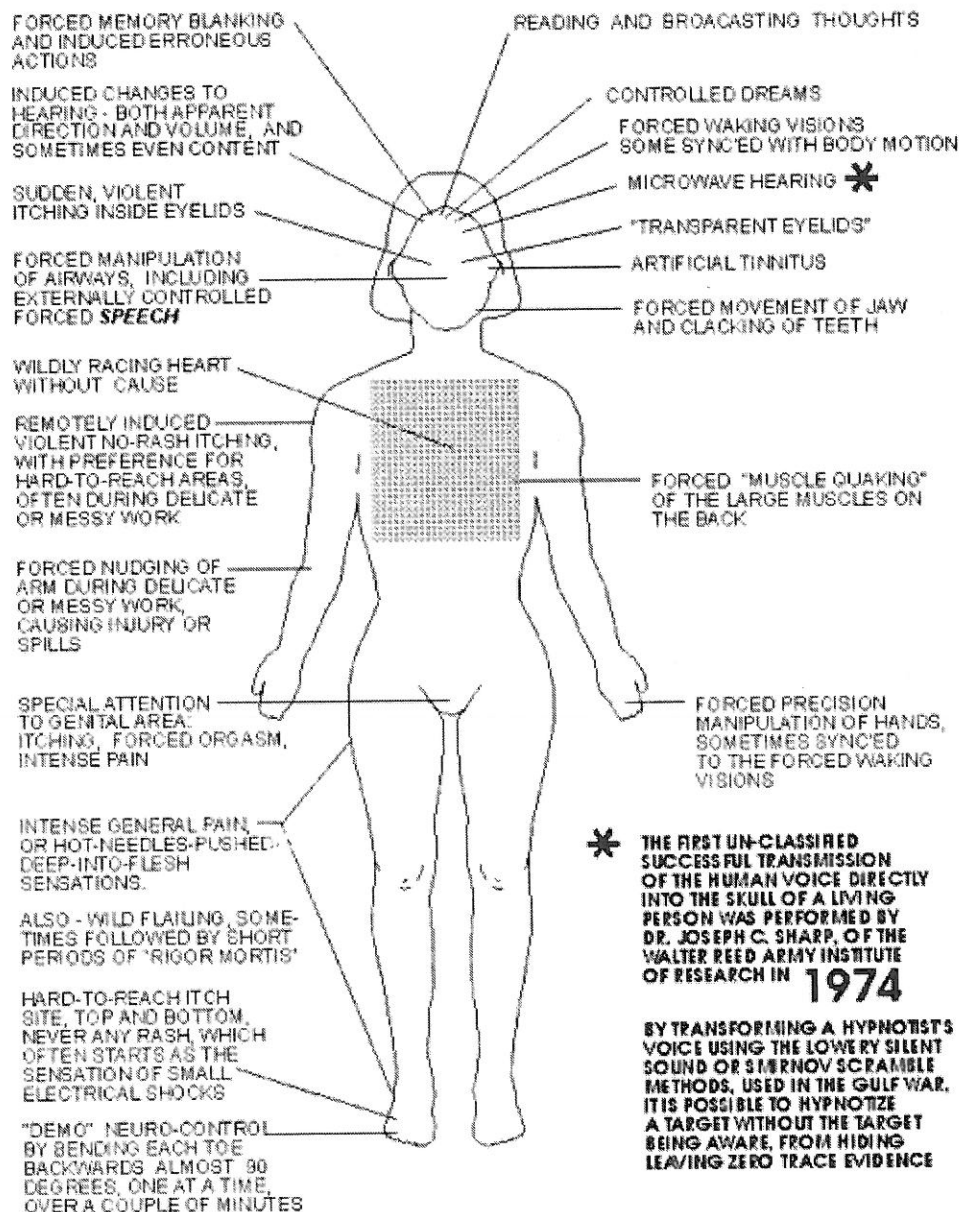

I am Deanna Williams a TI (Targeted Individual) American being electronically stalked and gang followed in my City/State Charlotte, North Carolina. I notice the harassment starting in 2011 when random people were hollering out of their cars calling me names such as, whore, prostitute and trifling ass. So I'm thinking these people cannot be talking to me; however, the same thing would happen to me in the community stores or no matter where I was. At this time I lived in Waterford Square Apartments in Charlotte NC. My attic was over my bedroom and bath room. I could always hear movement and bumping when I was in bed or in the bath room. I looked in my attic when I first moved to the apartment and the attic installation was very fluffy and neat; however, when the individuals finish crawling and lying on the installation over my bedroom and bathroom, the installation was flat as if someone was lying on it. I moved to The Retreat in Charlotte NC May

2012. Same occurrences. I heard the individual say, Don't worry we are going to get her. I'm tired of her lies. Not understanding what they meant, I paid no attention; however, the name calling continued when I was out in the community. When my Lease was up I moved again. One Caucasian Man attempted a break in while I was getting out of the shower; however, he did not get in due to my installing a latch lock and another Man entered my apartment without permission. I did report this to Landmark Apartments where I moved in April 2013 in Charlotte NC. While living at Landmark a continuum of harassment continued knocking on my door, hitting the wall where I slept from the outside, screaming and the stomping up and down on the stairway in the breeze way. I reported this to the Office Speaking to the office Manager and her Assistant Asia. Asia informed me that the reason I was hearing the Screaming it was a legal issue going on and she could not

inform me of what it was. I felt my life was in danger and I asked to move to a new apartment due to my apartment being in the back. I was the only one in the building being harassed. The apartment that the office offered each time was unfit. The harassment continued; however, I broke my Lease and I moved March 28, 2014. I moved to The Pines in Charlotte NC March 28, 2014. This puzzled me, I could not figure out why she would always say look at her. She thinks she cute and she think she is better than us. She would listen to my conversations and commented to where I felt as if I was being

stalked, because I ended up calling the Police several times and we ended up at mediation at the Apartment Office due to the screaming and noise. At night when I would try to sleep the screaming noise, walking above me with sounds as if chains were being dragged which happened all night, doors slamming, singing, preaching and acting. She and the Man would talk mean things to me and I would answer back until I got tired and called the Police. The last time before I moved, the Police took my gun because the individuals were making threats as if they would enter my apartment; however, I told the Officers I would protect myself. The Officers went to the Woman's door and of course no one answered her door. The Police took my only protection for safe keeping. Who was keeping me safe? Nothing was resolve. She denied everything. She was a easy target for someone like this Man to enter her home with trash. I was call a prostitute, snitch and trifling

ass because I called the Police and let others know what was happening to me. During all of the harassment I also had a tragic death in my family. My Nephew was murdered and one of my four year old Client almost died. I was also being harassed on my job. The stalking became even worse after the Police



was called. This man stated he had been following me for some years. I notice during the time of hearing these individuals no one could hear them but me. I started telling my family and they thought I was crazy. In the midst of this I had a nervous breakdown. I ended up going to Behavioral Health. This was the Stalker's goal. To make people think I was crazy and to get in a position of being alone where the stalking could continue. These people would always threaten me with doing something to my family or in particular my Daughter and my Granddaughter. They would make commits about my body parts and my grandchildren body parts and my

daughters. I notice the name calling when I was in the community continued but I ignored it. It has calm down a lot. I lost my job and by me spending all of my savings moving from place to place, I lost my residences. I lost a job of six years as a Foster Care Case Manager. I loved my job helping families. I am now living with my Daughter. I did not know what to make of all of the turmoil; I started praying asking God to give me guidance, so I started doing research on stalking. I knew I was not crazy but I am experiencing something beyond anyone's imagination, something like the twilight zone. I tried telling my Psychiatrist but she felt I was trying to make sense of my break down, in which I was but I did not want to be admitted, so I had to stop telling her about the continued stalking I am experiencing each day. These people never quit. I did my research and found [www.freedomfchs.com](http://www.freedomfchs.com) (Organized Crime of Covert Electronic Assault

and Surveillance) I spoke to one of the Founders Derrick Robinson in California where now they have assistance for individuals like me. Derrick gave me names and phone numbers of others in the surrounding area experiencing the same or close to what I am experiencing. I thought when speaking to these TI's, we are so much alike in our torturing. I felt sad but relieved to know that I am sane and there are individuals suffering as I am. I never gave permission for any instrument to be left in my body during any time of my operations nor did give permission to be put into any type government program as an experiment. I have had two cervical spine surgeries. I am experiencing shocking to my brain and body. I have a degenerative bone disease, progressing lapsed lungs and a cyst on my brain stem. Each day when these people torture me with their machine it is not good for my health and it is by God's grace that I am still alive. I make myself

get up each day because I refuse to give up. I feel these are some self righteous individuals whom call themselves whatever, stalking or harassing group in the public. In some results in other individuals may end up in death, suicide, mental illness or bad health which will still cost the Government money for disabilities. I do not know how this experiment begun and if it started out for something good but individuals are using it for wrong doings. I feel as if I am in the Tuckaseegee Experiment. Those days should be over. The Perpetrators that are stalking me has to have had some training in hacking because my computer and phone is always disrupting/glitching or my TV cutting off. Right before my leaving from my job, my computer was always glitching and information interrupted as I tried hard to complete a task. This Person must have had Technical, Officer, Military or Security training due to being able to see me in my home and other places

or training about the implant or maker of the implant that is in my body. All of these things add up. They could be some type contractor or investigator. I had a mental breakdown because of these stalkers and now I am a victim. I don't want my family or anyone else to become a victim. This is not all that I have been through. I have a log of the crazy things that I have experienced and now through Therapy, I am able to put things together. It keeps playing over and over what I am and did experience. I will never be the same. I am saying I have great empathy for people with mental illness and people suffering from stalkers torturing them. I cannot imagine the people like me not knowing where the shocking, noise and harassment is coming from. If they don't have God, they just might lose their minds. That is the goal for the perps and it seems as if they want you dead. I did my research on the VeriChip and Cointelpro. I do not know if

this chip was used during my surgeries or if Cointelpro is being used. Before these individuals came in my life, I was a happy person going to work every day enjoying life and traveling when I could asking no one for anything. I enjoyed my job as a Foster Care Case Manager. I enjoyed seeing the children's faces when they were reunited with their families. I lost my job of six years due to this turmoil. I don't want this to happen to anyone else. Help me. I am crying out. This is not fair to anyone that this is happening too. God tell us to seek, knock and we will find. I hope this letter reach several so this will not happen to anyone else. The definitions are as follows: TI Targeted Individuals targeted by OSEH for the purpose of human experimentation. OSEH Organized Staling Electronic Harassment method used by perpetrators targeting a specific person inducing harm or possibly death. DEW Direct Energy Weapon device used for OSEH

purposes, weapons can be microwave with pulp frequencies, v2k or other electronic and hearing devices. V2K Voice to Skull device is a weapon used for transmitting voices with low and high frequencies. Voices

can be for commands or harassment attacks that may look or sound like TI or others own voices. V2K induces and manipulate dreams or deprive TI's sleep. All of these things are occurring with me. I've done other research that I can share once someone contacts me. Only God knows how much more my body can stand from this. My life is in his hands. The Civil Rights are being violated on every side. No one in the United States should have to endure such torture. A few websites are Microchip Mind Control Implants and Cybernetics [www.mindcontrol.se](http://www.mindcontrol.se) published by Mind Tech Sweden and [www.geldon.wordpress.com](http://www.geldon.wordpress.com) What is Mind Control Psychotronic Torture. I found that stalking is against the Law Article 18 USCS 2261A Stalking 2013. And as I

was researching I read the information that former CIA Agent Dr. Robert Duncan noted and stated in his interviews.

How I know that this is true? And I no time and time again it has been hard to prove the stalking due to the individuals being trained not to get caught. If they get caught they are train to know that they will be on their own. I know one of my perpetrators. The perps job is to make me look discredited and intimidate me. But it is not working. My Mother and Grandmother taught me to fight for what is right. This is against my Civil Rights and my Family's Rights. IF I am placed in some Government Program, I need to know what for and why. I am not a criminal and I never sold my body and I am an independent or was an independent individual until I lost my places to live and my job recently June 2014 from a nervous breakdown behind the harassment and bodily harm electronically. I am willing to speak to a Lie Expert and take a Lie Detector Test. I offered these people to appear at the Police Department but they never wanted to resolve anything. I

feel I am being terrorized by a human terrorist.....Who are controlling these individuals who are trying to control everyone else? I have spoke to six people that is like myself experiencing some of the exact same things as me. This is not a coincidence because I do not know these individuals and they do not know me. We come from different states and families. In California I was told the Target Individuals finally got Aide to assist them with legal and other things that they need to get through this horrific experience and experiment. This is not something I should be going through in America. This is not what my Fore Fathers fought for, for me. I am a free individual. I pray this letter get in the hands and touch someone's heart to show some empathy for my situation and others like me.

It could be one of you or your family members going through this. I know now nothing is impossible when it comes to criminals and the impossible is possible.

Remember this person wants me to be discredited as if I am a liar.....Saying things about me that is not true.....Stating that he has pictures of me...No one I ever dated has taken photos or videos of me, I would not allow it. He and she would describe my Grandchildren and my body parts....Saying he would harm me and my family....You name it, he said it. I just want someone to reach out and help..... My body and brain is tired of the electrical shocking and sounds they inflict each day and night.

If there is help for individuals like myself out side of mental health, please let me know. This individual often said he was a Police Officer. I know a Government Official should not get civilians involved. I know what I am experiencing is unethical, racist, terrorizing, slavery, apartheid and I feel like an walking lab rat. I know that there are Human Lab Researchers that contract through Government Agencies and different Medical Researchers are doing it for Hospital and Doctors through my research. There are so many avenues that these Perpetrators can stem from. Please help.

### TESTIMONY

I am Asha L. Gibson born in Dillon, South Carolina. I am a resident of Greenville, South Carolina. I am a victim of Electronic Harassment ongoing. My case is in The United States Court of Appeal Fourth Circuit. I do have multiple symptoms everyday throughout my entire body. They consist of assaults, torture, and remote jerking of individual body parts. There are more to include, I choose to not to discuss at this moment. I do keep the assaults written down and texted to Douglas Campbell (PI) 843- 495-1394 and Millicent Black 931-374-5405. I do go to the doctor for the symptoms. I tell him what the situation is and not what caused it. He has told me several things are going on with your body in the past 4 years.

I have taken a polygraph to verify I am telling the truth of the questions; are you being electronically rape and are you being remotely tortured. I did have a psych evaluation. I have been in the mental hospital .I told them I felt someone touching on me and they said I was depressed and kept asking me have I ever been rape before,I said no until now. I have reported this crime to the local PD. She said she would commit me but I didn't look like I needed to in a mental hospital. She called a friend in the lower part of South Carolina and they prayed on the cell as if it was root on me. I contacted Derrick Robinson of Freedom From Covert Harassment and Surveillance. I heard James Walbert on the conference call. I contacted him through Derrick Robinson. James Walbert introduced me to Dr. Hildegard Staninger, Melinda Kidder, and Mr. William Taylor.

I reported this crime to the local FBI. I was told by one Special Agent to have the radio frequency body scan and see a neurologist. The other Special Agent said when you have your scan come back to see him, I saw them both at the same time. I completed several tests. He reviewed them and said they don't have the tools to do the search. I then continued my own investigation. I have contacted FCC, NTIA, DOD, DOJ, DOE, former Attorney General Eric Holder, former President William "Bill" Clinton Foundation, Civil Rights Division, Criminal Division and President Obama. I am continuously staying in communication with the Agencies and informing them I am awaiting for this information to present to

the court. I do EXPEDITE each FOIA request. I greatly appreciate your time in reviewing the testimony. I shall continue on until justice is served.
