This week I have been in contact with Bill Taylor and he said I would need to speak to your office and he has been in contact with the Aiken office and they are suppose to contact me on Monday. My husband has been verbally told today that he has been approved for disability. I had contact Mr Taylor requesting help in getting his disability approved so God is amazing answering prayers. Our problem now is we went ahead and contacted Medicaid to try to get that process going because all we had heard was as soon as he goes his disability apply for Medicaid and they will give him coverage. Well they won't because we don't fall into the income guidelines. My part time income alone disqualifies us. I contacted the insurance company that the Medicaid office referred us to and we were told that no insurance company will touch him because of his condition until January 1 when the Obama care health plan kicks in. My husband has serious heart disease and is on numerous medications and without coverage we are unable to pay for his medicines and doctor visits. What are middle class tax paying citizens suppose to do? Our system fails those that really need it. We are very lost in what we are suppose to do. I look forward to hearing from your office.

Dear Mr Taylor,

Thank you so much for talking with me yesterday regarding my husband receiving disability. When he checked the mail yesterday he received a letter from Assurant, his long term disability insurance carrier. In the letter they enclosed a form for us to sign stating that when my husband is granted his disability that we agree to reimburse them all the money they have paid back to the date that disability back pays him to. Are we legally responsible to pay them back? Long term disability is an insurance he pays for. We are not signing anything until we find out what our legal responsibility is.

My husband went to the social security office today and they said they didn't know. But they did say he had fallen through the cracks and has been approved and that money was deposited into our account today, but according to our bank it hasn't. He received an email in June saying his claim was being processed for disability but hasn't received an email or mail since. So we really are lost now. We were hoping to be able to pay off some of these medical expenses with any back pay but if we have to pay back Assurant then that will not be able to happen. We are going to go ahead and apply for Medicaid for him. We are lost and confused.

Dear Mr. Taylor,

I am writing you looking for help. Years ago Strom Thurmond was of great help to my family getting my sister disability. Now today we are fighting to get my husband, Johnnie Richard Smith Sr, disability. It has been applied for. Last October we found out the he had had several heart attacks and that the damage to his heart is extensive. The bottom of his heart has calcified and his ejection fraction rate is less than 20%. From October till March he had to wear a Life Vest, which is an external defibrillator, because he is at great risk of Sudden Cardiac Death. In January he had a double by-pass surgery, but they had intended for it to be a triple by-pass but because of all the damage they were only able to do a double. In March he had a pacemaker/defibrillator implanted. He began cardiac rehab and then in June he had another heart attack and had to start all over again. His energy level is extremely low because of the lack of blood flow to his heart. His doctor issued him handicap plates and told him that he would not be able to return to work. Emotionally and physiologically this has been extremely difficult for him. He is on anti depressants and anti anxiety medication. At the moment he is on long term disability through his employment but each day we live in fear that when they find out he is unable to return to work that they will release him and at that time he will no longer have any insurance which will be devastating to us. I am a Ministry Assistant at First Baptist Church Montmorenci and do not have insurance through the church. Because of how sick my husband is, I am only able to work part time. I have to carry him to his doctor appointments. The medication that he is on is a lot and will be on it the rest of his life and since his heart attacks his memory doesn't work as well as it use to. I have to be present at his appointments because he forgets to tell them things and doesn't remember what they tell him. My husband is 49 years old and he feels his world has fallen apart. I hate that we didn't meet you at church on Sunday but we attend the early service and this past Sunday he was too ill to attend. If you can be of any assistance in helping us with his disability we would be so grateful. Our world changed last year, but because of our faith in God, our church family and our families we make it through each day.
