We are presenting a bill in the next session with Brad Klippert in Washington state for a DOMESTIC VIOLENCE REGISTRY. We would like to also make this a NATIONAL DOMESTIC VIOLENCE REGISTRY. I have personally called every US congressman's office in all 50 states 435 phone calls and most senators personally to rally support in which we are gaining daily. I would like to meet with Dan Newhouse while he is out in Washington, but I know he is busy so if needed i can travel to him .If we could tie state law with a federal law requiring all Felony Domestic violence perpetrators to go on a national registry when a FELONY protection order is issued it would be automatic that the courts would put them on this registry then Maybe the next TINA STEWART will have a place to find out what they are getting into . Tina would of had no way of finding out if her killer had a violent past or not . She would of had no way of finding this out . because of financial reasons.So our proposal would fix this so they can find this out by a registry without having to pay a fee for a background check. If we create a national Data base free web site like we have for sex offenders, people can search before they take that date. THINK of the lives we may save. I have met with Ryan at Dan's local office I been in contact with Patty Murray and Maria Cantwell's office. We are working on setting up an appointment to discuss this issue will you please see if I can meet with Mr Newhouse . My Question is how many more Tinas have to Die or be murdered before we change our laws? Tina did not have 35 dollars to spend on background check, BUT she did have a cell phone .Tina was a single mom raising 4 children children her 2, my great niece and nephew, as well as 2 of my grandchildren. I am asking for support from all of our congressmen and senators in the United States. What we are proposing is really a no brainier. Not everyone has \$35 for a background check but we all have cell phones with internet or wifi capability. This could potentially save the lives of thousands of men ,women and children ,Not to mention LAW ENFORCEMENT would potentially know what they were dealing with . DOMESTIC VIOLENCE CALLS to law enforcement is a call most do not like I was a police officer in the 80s I cant amagin that it has changed much .In fact it has gotten much worse.
