

Palmetto Physician Connections will execute a primary care case management (PCCM) program that has a dedicated clinical focus to case and disease management. The Case/Disease Management program will operate in accordance with applicable standards for high quality provision of services, including EPSTD, HEDIS, and standards for the provision of health care to adults and children.

The aim of Case Management is to identify members with certain characteristics that place the member's health at risk. The Case/Disease Management team manages available resources for the achievement of optimum outcomes and is responsible for selecting high quality, not high cost care. The Case Manager is able to distinguish between the needs, wants and expectations of the member. In addition, focus is placed on the appropriateness and effectiveness of interventions.

The aim of Disease Management is to identify members with a particular disease process and through empowerment and education guide the member towards appropriate self-care. The Case/Disease Management team will facilitate communication between members and healthcare providers by recognizing each members individual needs and directing them to the appropriate care provider(s). The member learns to continually evaluate their health status, and understand the limitations of interventions.

Company Background

Palmetto Physician Connections is a limited liability company (LLC) and will have its corporate and administrative headquarters in Columbia, South Carolina. I currently own 100% of the company and am the sole officer.
