I reached out to DHHS to bring them into the healthcare conversation. Beth Hutto a deputy with SCDHHS worked for the Tennessee Medicaid agency on their consent decree, so I think she will have valuable insight. She also thought their MCO, Select, will be very helpful in this conversation. Apparently, all foster care children are assigned to Select, so they will have data related to this population. I told Beth we would start by sending them the proposed healthcare provisions for review and would follow up with a meeting with them first and then with Select.
