Of the 19 pending cases on the Patient Protection Report, nine (9) are being retained by SLED as potentially criminal; seven (7) cases were referred to the State Long Term Care Ombudsman’s Office (SLTCOO) in the Lt. Governor’s Office on Aging; three (3) were being investigated by the Attorney General’s Office. Mark gave an historical overview of why we report allegations of patient abuse to outside agencies.

Ms. Spencer invited everyone to do an exercise to show the difficulty and challenges that goes along with having Tourette’s and her particular tics. The exercise involved writing the Pledge of Allegiance while experiencing 4-5 tic episodes in a minute. Emma Harris, another Governor’s School Student, briefly spoke about her illness and the fact that she will not let it be a deterrent in her life.</p> <p>Bonnie Pate introduced Zoe Miller to the Commission and everyone present. Ms. Miller is a 15 year old student who created a documentary on Lloyd Hale, a Peer Support Specialist at Charleston-Dorchester Mental Health Center, focusing on his recent bicycle ride across South Carolina to raise awareness of mental illness, “Ride for SPMI.” Like Mr. Hale’s bike ride, the documentary will help bring awareness to serious and persistent mental illness. Mr. Hale spoke about the experience after the film was shown.</p> <p>There was a groundbreaking this week for the baseball stadium. Shortly, after the ball field is under construction, we understand that groundbreaking will begin for the commercial sites. SCDMH will discontinue allowing public visitation to the campus due to the potential hazards with all the construction occurring. However, the agency does still permit law enforcement training for the time being. Further discussion will be held in a recommended Executive session regarding contract issues.</p> <p>Mark Binkley noted that SCDMH is still projecting a surplus at the end of the year (with the use of agency non-recurring funds). We are expecting the Governor’s budget recommendations to come out soon. SCDMH will have its budget hearing in front of the House Healthcare Subcommittee on January 21<sup>st</sup>.</p> <p>Geoff Mason introduced Louise Johnson, Director of Children, Adolescents and Their Families, and Sylvia Senbel, School Based Services Program Manager. They gave a brief overview of DMH School-Based Services and where we are now with this program. At the end of FY14, there are a total of 460 schools that have DMH counselors on-site providing treatment services; and at the end of the 1<sup>st</sup> quarter of FY15, we have increased this number to 482 schools. Commissioner Rutledge asked how students were alerted to the fact that the DMH counselors are in the schools to assist them. Ms. Johnson noted that the counselors train teachers and school personnel on ways identify students who may be in need of a counselor and many are referred by teachers and administrators. Over time, students become aware of their availability, and are able to self-refer. SCDMH has</p>

<ul style="list-style-type: none"> <li>• <b>Potential Changes in Reimbursement – Mark Binkley</b></li> </ul>	<p>counselors in alternative schools as well as regular schools.</p> <p>Mark Binkley began by stating that almost half of the agency’s operating revenue is earned through the provision of clinical services. There is a great deal of debate and activity involving large payers, like Medicare, Medicaid and health insurers, looking at new and different ways to reimburse providers for healthcare services other than the traditional fee-for-service method. The discussion is being driven in part by the increasing cost of healthcare. But it is being driven in part by concerns about the quality of the services. The question being increasingly asked by the large payers is “Are we getting good value for the money we are spending on healthcare services?” Data does not indicate that, as a country, Americans are seeing improved health outcomes despite the fact that America spends more on healthcare per capita by far than any other country. So recently the quality concerns are being joined with the cost concerns, and many types of changes are being considered by payers to the ways in which providers are reimbursed for their services. As a large healthcare provider, DMH has been closely following these developments and making its position and concerns known in the discussions which are taking place in South Carolina. The purpose of this presentation is principally to make the Commission aware of issues that may impact the agency in the future. Commissioner Rutledge noted that so-called “managed care” was often just a divide of the money and would not improve the agency’s ability to meet the needs of our clients. This is a huge concern and if there is an opportunity for the Commission to speak up they will do so.</p>	
<ul style="list-style-type: none"> <li>• <b>Resource Acquisition Initiative – John Magill</b></li> </ul>	<p>Mr. Magill described this initiative to assist Center Boards and Center management make the case for increased Center funding from County governments as being outstanding thus far. A lot of interesting conversation has been taking place. One county council member stated that their council elected to defund the local Center because they thought it was a charitable organization. Mr. Magill feels that this initiative gives us an opportunity to educate county council as well as Center board members, and that will result in more Counties providing local funding to Center operations.</p>	
<p><b>OTHER ADDITIONAL COMMENTS</b></p>	<p>Rep. J. Derham Cole, Jr., a new member of our House Budget Committee, met with Senior Management and toured G. Werber Bryan Psychiatric Hospital. Rep. Cole was very appreciative for the information on SCDMH. The Duke Endowment will meet with Mr. Magill and other SCDMH staff members next week to discuss a School Based Telepsychiatry proposal that the agency would like to pursue.</p>

<p><b>DEPARTMENTAL OVERVIEW AND UPDATE</b></p> <ul style="list-style-type: none"> <li>● <b>Legislative Update – Mark Binkley</b></li> </ul>	<p>Mr. Binkley called the Commission members’ attention to Volume 1 of the DMH Legislative News dated February 2, 2015. The SCDMH FY 2016 Budget Request Comparison chart on the front page reflects the information which was sent to Commission earlier. The first budget hearing in front of the House Ways &amp; Means Committee took place on Wednesday, January 21, 2015, which went very well. Mr. Binkley pointed out several bills by discussing their content in a little more detail than what was provided. Of note, one bill that was not listed in this legislative issue has to do with the Certificate of Need (CON) process. If this bill passes, it will take away a lot of required review from the DHEC, which would essentially mean that hospitals would be able to change their bed types without going through the process of a CON.</p>

The developer is continuing to seek prospective sub-developments. The City of Columbia Police department leadership met with DMH Public Safety regarding taking over primary policing of Bull Street, all except for Hall Institute.</p> <p>The agency’s projected surplus has increased since last month by approximately \$1.5 million. The majority is an expected increase of revenue from the VA Nursing Homes because the VA increased their rates of reimbursement, which was retroactive to October 1, 2014. As always, it’s important to keep in mind that the projected surplus is only a surplus by including the amount of non-recurring revenue the agency is still utilizing for its operations. Mr. Magill added that should we receive the requested amounts from the General Assembly for Sustainability and Forensics, we would be just about at a breakeven point. Our revenue per billable hours and per patient reimbursement rates are both increasing. We will soon be able to expand in things that are high value, best practices.</p> <p>Mr. Mason called the Commission’s attention to the talking points concerning the housing initiative. Since 1991, DMH has developed over 1600 housing places for our patients. And yet, from the recent Housing Task Force Report, we know that there still exists a need for adequate housing for over 5000 individuals with mental illness. We are requesting \$400,000 in recurring funding from the general assembly to help address the housing shortage.</p> <p>In addition, Mr. Mason presented information on outcome volumes. A comparison of quarters 1 &amp; 2 of FY14 versus quarters 1 &amp; 2 of FY15. We have had increases in the number of new cases, billable hours, overall services and the number of clients served. Data regarding percent of intakes meeting access standards, collaborative documentation and productivity were all discussed. DMH is above standard in each of these outcome areas but we do realize there is a lot of room to continue the improvements.</p> <p>The total of collections from July 1 – December 31, 2014 was \$183,578.12. The amount of revenue we have received from collections over the past two years has pretty much stabilized. Mr. Binkley added that this is revenue from all involuntary collection measures, which are primarily from self-pay patient accounts, and also primarily collections of inpatient charges. The number of inpatient beds has been going down; the</p>

Senior Management has met with the three (3) staffers who will be doing the work to give to the sub-committee for our audit review. DMH is the only large agency that will be reviewed this first year by the Senate. It may be possible that our review may be a precursor to how the other audit reviews will be conducted. This is the first time in South Carolina that this has been done. They have asked and received lots of information about our agency already.</p> <p>Mr. Binkley presented an outline of a behavioral health home model for Community Mental Health Centers. The Department is interested in pursuing this model with the State's Medicaid agency, and thinks it would be a better model for the patients with serious mental illness, than a managed care approach. If implemented correctly, it would save money for Medicaid while improving the patients' mental and physical health. Essentially, an enhanced level of outreach and clinical services would be provided by a Mental Health Center to a targeted the population of patients who have a serious and persistent mental illness and are also high utilizers of emergency or other high cost services. DMH is encouraged that recently, following the change in agency leadership, SCDHHS has partnered with DMH in applying for a technical assistance grant aimed at helping States establish behavioral health homes.</p> <p>Mr. Magill reminded the Commission that he approached The Duke Endowment about a the possibility of funding a pilot program combining Telepsychiatry and School-Based Services. We have prepared a White Paper and a preliminary budget. The Duke Endowment appears very interested and they want to be involved in the planning for such a program. We have missed the funding cycle this year but hopefully, by next Fall we will get approved.</p> <p>DMH has received approval by the Joint Bond Review Committee and Budget and Control Board for establishing a project for a new State Veterans Nursing Home. We are hiring an Architect/Engineer and preparing a construction grant application to submit to the Veterans Administration. The application is due by April 15<sup>th</sup>. The Governor has named Mr. Magill as the official person from South Carolina to sign off on the State's</p>

	<p>\$12,250,000 and the full Committee recommended \$11,000,000. There are recurring amounts in the Department's current budget that enable the agency to dedicate funds for the future Veterans nursing home project as well as our deferred maintenance and capital needs, such as a new Santee-Wateree Sumter clinic. The Senate Oversight Committee meeting earlier this week went very well.</p> <p>Mr. Binkley proposed, since the legislature is moving towards requiring all state agencies to publish their meeting agendas online, that DMH begin to publish our SC Mental Health Commission agenda online at least 24 hours prior to the meeting. In addition, Mr. Binkley recommended that the Commission go on record at each meeting to formally approve the Agenda at the outset of the meeting.</p> <p>In regards to the Patient's Rights bill, DMH is seeking a change that will be allow the hospitals utilize Advanced Practice Registered Nurses (APRNs) to perform required initial physical examinations of patients, which they are already qualified to do as part of their State licensure. Basically, DMH is simply proposing to amend the laws pertaining to professional practice in DMH hospitals to be in line with what other hospitals in South Carolina are able to do. This would be a good way to assist with our physician shortage.</p> <p>Also, the General Assembly passed a Joint Resolution recognizing and commending the Agency on the recognition of the DMH ED Telepsychiatry Consultation Program as a "Bright Idea" by the Harvard University Ash Center for Democratic Governance and Innovation at the John F. Kennedy School of Government. We have received \$6.2 million over the years from the General Assembly for Crisis Stabilization efforts. The RFPs that were put out this year to the Mental Health Centers resulted in proposals totaling \$7.4 million. We require outcomes from the Centers to see how they are progressing. We are also looking at our EMR for performance measure compliance. There are changes coming in from CMS and SCDHHS. The department, on a regular basis, is looking at payments and patterns within the billing by the Mental Health Centers. We are monitoring because if there is a significant increase in billing of a particular service, we need to determine the reason, as we are likely to be asked for a justification by DHHS. There is an emphasis by Medicaid on the requirement that clinicians develop and put in writing achievable, realistic treatment plans for patients. Nationwide, this has been a problem in terms of compliance for many healthcare organizations. The QA committee developed a subcommittee to look at this issue in depth. There have been hundreds of hours of training provided to staff, but the problems with inadequate treatment plans persist. The Patient’s Rights bill is one of our agency’s bills in that it allows DMH to use “Authorized Health Care Provider” to be used in DMH hospitals in the same manner as other healthcare facilities do in that they will be able to perform required initial examinations and to authorize some medications and treatment to patients in DMH facilities. The last bill of major interest to our agency is the Able Savings Program. Mr. Bill Lindsey of NAMI commented briefly on the Able bill which would enable persons with disabilities or their families to establish savings accounts as a means of empowering individuals with a disability and their families to save private funds to support the individual with a disability, without adversely impacting their eligibility for Medicaid.</p>

The Patient's Rights bill was passed. This bill adds and defines the term "Authorized Health Care Provider" and allows them to perform required initial examinations in DMH facilities. It essentially allows them to provide the same services in DMH hospitals that they are allowed to provide in other hospitals. The Body Camera and Release of Child's Medical Records bills passed. The SC Able Savings Program has not passed as of today. Representative Pitts has sponsored a bill regarding outdated language in regards to our Public Safety division. Bill Lindsey mentioned that the Governor signed the Mental Courts bill this week.</p> <p>We are moving ahead to get approval on the sale of the Hall property. Mark Binkley and Kim Carter met with the Attorney General's office regarding this sale. There have been some conversations with the Buyer about which parcels are likely to be the next to sell. SCDMH is under budget due to several factors. We have received higher than expected revenue from the VA, Medicare and Medicaid. As discussed previously, we have a significant number of unfilled positions. Mr. Magill asked if SCDMH is at a point where, following the additional appropriations anticipated for FY 16, our projected revenue will match expenditures, and the agency will no longer reliant on one-time, non-recurring funds to pay for operations. Mr. Schaefer answered that yes we are very close to this now, which would be the first time in about six (6) years.</p> <p>Dr. Everard Rutledge gave a brief update on the Governor’s Domestic Violence Task Force. Approximately three (3) weeks ago the preliminary report was released. Dr. Rutledge served on the Criminal Justice Subcommittee and spoke of the work that committee is doing. One of the goals of this subcommittee is to develop templates for the smaller law enforcement agencies to have protocols in place to properly investigate domestic violence allegations. One of the proposals is to have the smaller departments report incidents to the County Sherriff’s department, as they are large enough to have sufficient resources to do a thorough investigation. Mr. Magill added that Drs. Rutledge, Gunter and Benedetto will meet next month prior to the next Commission meeting for further updates on how SCDMH will proceed.</p> <p>The most recent RAI board training took place in Denmark and Orangeburg. DMH also received funds for a number of its one-time funding requests, for such things as the second installment for the inpatient Electronic Health Record and for mandatory upgrades and improvements for electronic information security. The first installment in the amount of \$500,000 for Columbia Area Mental Health Center’s Phase III Building Project was vetoed by Governor Haley, but it was later overridden by the General Assembly.</p> <p data-bbox="606 781 1692 914">David Schaefer noted that there was very little change in the final FY 15 budget from the information presented last month. The Finance Department is working to close out FY15 and open FY16. Meetings are underway with each individual departments/division to review their FY 16 budgets.</p> <p data-bbox="606 959 1713 1166">With the FY16 budget we received the final installment to be able to move forward with our construction project for a new Santee-Wateree Mental Health Center in Sumter, South Carolina. The IAP asks the Commission to approve the acquisition of the proposed site (formerly the site of a drive-in movie theatre). There was one (1) incident under the Patient Protection and Client Advocacy Report, disciplinary action is still pending. Of the thirteen (13) pending cases on the Patient Protection Report, seven (7) are being retained by SLED as potentially criminal; four (4) cases were referred to the State Long Term Care Ombudsman's Office (SLTCOO) in the Lt. Governor's Office on Aging; and two (2) cases are being investigated by the Attorney General's Office alleging financial exploitation by a family member and a CRCF operator.  There are no remarkable trends in the Client Advocacy report. Issues are being regularly and routinely addressed by facility and center staff advocates.	
<b>Key Statistical Data/Inpatient Report – Versie Bellamy</b> <b>DEPARTMENTAL OVERVIEW AND UPDATE</b>	Ms. Bellamy commenced by acknowledging DMH's IT Department, particularly Leigh Ann Chmura, for collecting the data used in the Division of Inpatient Services (DIS) 2015 Utilization Data Report being presented today. This information reflects the Division's overall ability to adapt to change, crisis and normal trends associated with a 24/7 healthcare environment. New Admissions/Readmissions increased slightly from FY14 to FY15; there was no change in discharges between the two fiscal years; a 1.44% increase in number of patients served, which includes adults and children; a 1.98% increase in DIS bed days; and the average daily census has increased by 1.82%. Dr. Evans asked how the agency is doing with

Telepsychiatry has reduced our inpatient waiting lists significantly. Due to the implementation of the ED Telepsychiatry consultation service, participating hospitals are able to discharge a large percentage of behavioral health patients from the ER to the community. Patrick B. Harris Psychiatric Hospital statistics show that over 50% of ED patients about whom they are initially contacted for an available bed are stabilized and discharged home, so ultimately do not require a hospital admission. Mr. Magill added that Dr. Narasimhan, USC School of Medicine, will be providing DMH with RO1 data that will show extremely positive information regarding our ED Telepsychiatry initiative. Under advisement by Mr. Magill, Versie Bellamy and her staff have been asked to refine or redefine the waiting list to better reflect those who truly need admission, and to re-examine the Morris Village waiting list for voluntary admissions.</p> <p>Mr. Mason presented the “scorecard” for the community mental health system. There has been an upward trend in the following categories from FY14 to FY15: New cases/Readmissions up 3.17%; Billable hours up 3.88%; Number of overall services (children and adults) up 4.50%; Number of clients served (children &amp; adults) up 2.50%; Percent of intake meeting access standards is at 84% statewide; Collaborative documentation up by 18%; and Productivity for all centers is approximately 788.18 hours, up from the standard of 720 hours. Beginning November 2015 to November 2016, the new benchmark standard for productivity will be 820 hours. The center directors will have a retreat in September. We will look at where we were in comparison to where we are now to see how we can improve in the future. Sharon Wilson asked if the supervision hours in the P&amp;L will be quantified, to which Mr. Mason replied, yes. Bob Hiott asked if new cases and readmissions (within 30 days) could be broken out. Mr. Mason and his staff will look into this change. Ms. Wilson asked if we are billing for everything that we could possibly bill for to which Mr. Magill stated that this is something we need to look into because we could possibly do more.</p> <p>Mr. Magill suggested that a tour be arranged after the September meeting for the Commission members to take a tour of the developments to the Bull Street Property. The Stadium and adjacent building are progressing well and appear to be on schedule to have their first game the third week in April, 2016. Mark Binkley presented the Issue Action Paper (IAP) regarding the use of proceeds from the sale of the Bull Street Property. The IAP recommends that the agency use the current proceeds as a one-time matching funds for the development of new affordable housing for patients. Of the \$1,135,355.98 collected on medical accounts during January 1<sup>st</sup> thru June 30<sup>th</sup> of this year, \$964,311.81, which is 78% of total collections, was obtained through the debt set-off collection process through the State Department of Revenue.</p> <p>Mark Binkley called everyone’s attention to the financial information in their packets. Our expenditures went up significantly from FY 14 to FY 15 (FY14 was \$352,369,234 and FY15 was \$373,930,214) due to the significant increase in state appropriated funds. There was also a significant increase in Medicaid reimbursement, which was primarily related to an increase in rates and an increase in patient volume, and VA reimbursement. As a result, the amount of non-recurring funding that the agency needed to balance was reduced by over \$5 million from FY 14 to FY 15. As discussed previously, the Department also continues to have a significant number of unfilled positions, which is an area of continuing focus by management.</p> <p>The next RAI training will take place in late August at both the Piedmont Center for Mental Health and The Greenville Mental Health Center. The S.C. Mental Health Commission met at the Catawba Mental Health Adult Center on Friday, October 2, 2015, at 9:00 a.m. Commissioner Moore expressed appreciation to the center for the courtesies extended to the Commission during its visit. Mr. Steve Sanders provided the invocation. Commissioner Moore then turned the meeting over to the center director, Paul Cornely, Ph.D. Dr. Cornely welcomed the Commission back to Rock Hill and Catawba Mental Health Center and thanked the Board members, DMH senior management and the Commission for the support given to the center. He then asked all members of the senior management team at Catawba to stand and introduce themselves.

**Presentations** - Dr. Cornely briefly gave an overview of the results of the FIN Initiative for Catawba Community Mental Health Center (CCMHC). Collaborative documentation, routine (non-urgent) and urgent appointments along with emergent same day access to care were topics discussed. Ms. Sheena Willis followed with a presentation on York Adult Outpatient Services. On August 3, 205 York Adult began servicing clients at 205 Piedmont Boulevard, Suite 100. Currently, York Adult Clinic has over 1365 active clients and a total of 934 admissions for FY2015. Some of the programs and services offered at York Adult include, but are not limited to, Care Coordination, Dual Diagnosis, ACT-Like, Intake/Crisis, Crime View and Peer Support.

Brenda Parker gave an overview of CAF Services. Services such as Parent Child Interactive Therapy (PCIT), Trauma Focused Cognitive Behavior Therapy (TFCBT) and CAF staffing were all discussed. Ms. Parker noted that two years ago when the Commission was last at Catawba, she and Yvonne Stewart, York County Department of Social Services, described a protocol entitled, "Enhanced DSS/MHC Protocol Assessment", which is a community collaborative. The intent of the protocol is to immediately address the trauma that the child and family members experience at the child's removal. It is a system to bring children and families together with a families other than their immediate family. This protocol, which will help determine the level of care a child needs, has been examined and will be implemented statewide very soon.

Kevin Burroughs, CCMHC's Peer Support Specialist, brought two of his clients to his presentation to show what peer support for mental illnesses looks like and to show how well it is working. Mr. Burroughs reiterated that peer support changes lives for the better.

Liz Seeger, York County School Based Services Coordinator, was the last presenter. Currently, there are 60 schools in York, Chester & Lancaster Counties who use our school based counseling services. One parent was present to share her relationship with school based counselors and how this program has enhanced the lives of two of her children.

Dr. Evans thanked everyone for their excellent presentations.

There being no further discussion, the center presentation concluded at 10:05 a.m.

<b>MONTHLY/QUARTERLY INFORMATIONAL REPORTS</b>	Mark Binkley presented those items listed under <b>Monthly/Quarterly Informational Reports</b> . There was nothing remarkable to report on the Patient Protection and Client Advocacy Reports. Of the 24 pending cases on the Patient Protection Report, thirteen (13) are being retained by SLED as potentially criminal; seven (7) cases were referred to the State Long Term Care Ombudsman's Office (SLTCOO) in the Lt. Governor's Office on Aging; two (2) were being investigated by the Attorney General's Office; one (1) has been referred to a local law enforcement agency; and one (1) to DMH Client Advocacy. Of the cases closed during the preceding month, there were no substantiated allegations.  Last month, since there was an increase in the number of client advocacy reports, Rochelle Caton noted that we would monitor this over the next few months. However, it looks as though there is no trend at this time as the number of cases this month dropped back to the average range.

Mr. Barnes-Young commenced by stating that four years ago Tri-County partnered with a Federally Qualified Healthcare Provider (FQHC) and a hospital at different periods of time to deliver integrated primary care to its Mental Health Center patients through a Substance Abuse and Mental Health Services Administration

<p>● <b>Report of Inpatient Facilities Governing Body Meeting – Versie Bellamy</b></p>	<p>(SAMHSA) Grant. Some of the reasons to integrate care for behavioral health patients include the following: 1) mental health, substance abuse, and physical health conditions impact each other; 2) the cost of treating physical health conditions increases significantly when co-occurring behavioral health conditions are present; 3) integrated care is effective; and 4) co-occurring health conditions are the rule in patients with serious mental illness, not the exception. The Department is developing a Behavioral Health home model for Mental Health Center patients who have one or more co-occurring health conditions. The approach will embody best practices to include population health management to reduce health disparities, motivational interviewing, trauma-informed care, collaborative documentation, peer support services, open access/enhanced scheduling and tobacco recovery and control programs. There are several cost and buy-in challenges to integrated care such as recruitment of skilled professionals, establishing and maintaining effective partnerships, cost of certified electronic health record to practice population health management, transportation, developing an integrated health record and agreed use of health information technology, and a willingness to participate in shared risk payment models. Nevertheless, it is the proven approach for improving patient health, and is clearly the approach which will be expected of providers by the major payors for healthcare in the future.</p> <p>The Inpatient Facilities Governing Body Committee meeting minutes from the July 8, 2015 meeting were presented for approval to the Commission. William S. Hall Psychiatric Hospital is due for a triennial Joint Commission survey. Joint Commission has agreed to extend the survey until the end of the month to allow for the move to the G. Werber Bryan Psychiatric Hospital campus. Ms. Bellamy gave brief highlights of the meeting as it related to accreditation/regulatory surveys, plan for services/scope of services, recruitment and retention, and performance data for each inpatient facility. Video cameras have been installed at C.M. Tucker Roddey and Stone. The roofing project at C.M. Tucker Roddey is set to be completed in a few weeks. Commissioner Moore commended the C.M. Today is the deadline for State agencies to submit their 2017 budget request to the Governor’s office. The Department is seeking an increase in its recurring general appropriations in excess of \$21.0 million. A majority of the increase is for the hospitals and long-term care facilities. It was hard to estimate the increased costs for Veterans’ Victory House and Richard M. Campbell Veterans Nursing Home because both are in a contract renewal period. The agency will also be increasing the number of beds at C.M. Tucker/Stone. The costs of the Forensics program are increasing as the number of orders for evaluation and commitments increase. Management is also projecting a significant increase in the cost of the Sexually Violent Predator Treatment Program related to a current Request for Proposals (RFP) as well as projected increases in the census. Mr. Binkley recommended additional discussion of the RFP take place in Executive Session. Other projected increased costs are for the creation of a central clinical contract monitoring program, and for greater hospital and community IT support services.</p> <p>Versie Bellamy introduced her team to include Dr. Allyson Sipes, Dr. Kimberly Rudd and Stuart Shields. The Forensics division has been in consultation with Circuit Court Judge Frank Addy to discuss some opportunities for improvement in conducting evaluations and reducing the waiting list for forensic patients. In response to this challenge, Ms. Bellamy appointed Dr. Allyson Sipes to provide direct management and oversight to give more focus in this area and to get court ordered evaluations caught up. With the utilization of some contracts with private psychiatrists and psychologists, Dr. Sipes reported that we are now scheduling evaluations as the Orders are received. As we go forward, we are looking to contract with two additional private practice psychiatrists for ongoing assistance. We are also improving the data tracking process and working very closely with IT. Ms. Bellamy and Dr. Sipes thanked the legal staff, especially Alan Powell and Monique Lee, for all of their assistance.</p> <p>Mr. Mark Binkley began by reminding the Commission of a memo that was sent out detailing monies received by the Department from recent parcel sales that took place a week and a half ago. This presentation went very well. As a result, we are repeating this presentation on November 16, 2015. This time the audience will include members of the Blue Cross/Blue Shield Foundation, the Duke Endowment, the Senate Legislative Oversight, Legislative Audit Council, and budget staff from the House and Senate. South Carolina’s application was ranked 6<sup>th</sup> overall in terms of quality.</p> <p>This is a statewide grant but we will focus closely on the seven (7) counties which have the highest rates of suicide (Beaufort, Lexington, Berkeley, Spartanburg, Greenville, Charleston &amp; Richland Counties). Youths and young adults ages 10-24 will be the targeted population. This is a five (5) year grant that has a maximum funding of \$736,000 per year. Funds will be used for evidence-based best practices in reducing/preventing youth suicide. These measures include emergency room rapid follow up services following an unsuccessful attempt; timely care transition and coordination; raising public awareness and the awareness of adults who work with children and adolescents concerning the signs and symptoms of depression and what to do if they become concerned; and raising awareness of youth through Young Lives Matter of what resources are available if they are having feelings of despair or thoughts of suicide. We have already begun to work on reinstating the State Suicide Prevention Coalition and implementing the regional suicide prevention task forces. We are hoping to partner with Dr. Meera Narasimhan and the USC School of Medicine in order to provide a very strong evaluation component.</p> <p>There have been no more scheduled sales of parcels. The sewer replacement project is still ongoing. The flooding set this project back a bit.</p> <p>Versie Bellamy noted that the transition had been on schedule to move to the Bryan campus but due to the floods, we have been set back. We are expecting an inspection from Joint Commission at any time. Dr. Forand added that once the transition has been completed, we will see Joint Commission once again in the new facility. The Notice of Completion has been issued by DHEC for the two (2) lodges and the school. We are probably looking at physically moving in December. The lodges are divided into pods of which there will be three (3) pods in each building. This will allow for smaller sub-communities the facility. The bedrooms will be primarily private and all bathrooms will be private. All of the furniture is child-friendly and more “home-like” which will create a better atmosphere for the patients. There will be a fence to provide separation between the children and the adults. Mr. Magill announced that we hope to have an Open House sometime after the first of the year.</p> <p>Dave Schaefer called everyone’s attention to the financial information in their packets. Medicaid and payroll expenses are coming in a little lower; we are watching both of these.</p>

<b>CALL TO ORDER</b>	The December 11, 2015 meeting of the South Carolina Mental Health Commission was called to order at 10:35 a.m. by Alison Y. Evans, Psy.D., Chair, at the Lexington Community Mental Health Adult Center, 301 Palmetto Park Boulevard, Lexington, SC. Ms. Karen Busha provided the invocation.	
<b>INTRODUCTION OF GUESTS</b>	Dr. Evans welcomed regular attendees; there were no guests.	
<b>APPROVAL OF AGENDA</b>	<i>On a motion by Buck Terry, seconded by Beverly Cardwell, the Commission approved the agenda for today's Business Meeting.</i>	
<b>APPROVAL OF MINUTES</b>	<i>On a motion by Buck Terry, seconded by Sharon Wilson, the Commission approved the minutes of the Commission Business Meeting of November 6, 2015.</i>  <i>All voted in favor to the above motions; all motions carried.</i>	
<b>MONTHLY/QUARTERLY INFORMATIONAL REPORTS</b>	Mark Binkley presented those items listed under <b>Monthly/Quarterly Informational Reports</b> . There was nothing remarkable to report on the Patient Protection and Client Advocacy Reports. Of the 19 pending cases on the Patient Protection Report, eight (8) are being retained by SLED as potentially criminal; nine (9) cases were referred to the State Long Term Care Ombudsman's Office (SLTCOO) in the Lt. Governor's Office on Aging; and two (2) were being investigated by the Attorney General's Office. Of the cases closed during the preceding month, there were no substantiated allegations.	
<b>• Corporate Compliance Update – Ligia Latiff-Bolet, Ph.D.</b>	Dr. Latiff-Bolet commenced by stating that the Compliance Department (Department) is reviewing their entire program. They are extending Community Mental Health Centers (CMHCs) audits up to 18 months to accommodate medical record audits for the Division of Inpatient Services (DIS) as well as reviewing procedures for reimbursement. These program changes have been approved by Mr. Magill as well as the Department of Health and Human Services (DHHS). The Department has standardized credentialing. For the last six months, compliance with Local Coverage Determinations from Medicare for Patrick B. Harris (Harris) and G. Werber Bryan Psychiatric Hospitals Acute Adult Services is steady at 97%. Closed Medical Records for the last six months is also at 97%. Audits of coders started last month. A total of 89 records were reviewed for accuracy and diagnostic coding. There was a 97% accuracy at William S. Hall and a 92% accuracy for Evaluation and Management Services. Regarding the CMHCs, ten of the sixteen centers had >90% overall performance; sixteen of

The mode was 86% and the range was 82-92%. The HIPAA/Privacy/Security 1<sup>st</sup> Quarter results were given: Inpatient – 18; Outpatient – 51; Administration – 9. Of the 82 reported cases, 10 were unauthorized access/disclosure, 67 hacking/virus IT; one (1) lost/unaccounted for; four (4) other and one (1) HHS reportable.</p> <p>Mr. Lee Pearson, Director of Operations at the Institute of Medicine and Public Health, began the presentation on the Long-Term Care Task Force Initiative. Mr. Pearson began by giving a brief history of the Task Force along with the list of members who participated. The report was released on June 10, 2015. The 30 recommendations were broken down into sub-headings to include promoting efficiencies in the system; strengthening the long-term care continuum; ensuring an adequate and trained workforce; protecting vulnerable adults; supporting family caregivers; promoting choice and independence through education; and future directions which include the development of the Implementation Leadership Council to work on follow through with each recommendation.</p> <p>The Inpatient Facilities Governing Body Committee meeting minutes from the October 14, 2015 meeting were presented for approval to the Commission. All three (3) Joint Commission accredited hospitals had their surveys. There were only four (4) minor citations of which two (2) are being contested. G. Werber Bryan Psychiatric Hospital construction continues. The plan for William S. Hall Psychiatric Hospital is to move into the new accommodations on Tuesday, December 15, 2015. Mr. Magill noted that the buildings are DHEC approved but there will not be a formal dedication ceremony until the early part of next year. Renovations are continuing at our long-term care facilities. Electronic Medical Records kick-off for DIS will take place in January. Commissioner Rutledge noted the number of clinical staff support at the long term care facilities is significantly low. He knows that this is due to the very low pay scale for clinical support such as certified nurse assistants. He has recommended that this issue be studied and addressed in the coming year.</p> <p><i>On a motion by Joan Moore, seconded by Buck Terry, the Commission approved the Governing Body Meeting minutes from the October 14, 2015 meeting as presented.</i></p> <p><i>All voted in favor to the above motion; motion carried.</i></p>

Mayor Benjamin and Hughes Development recently made news by stating that there will be an announcement of new tenants by the end of the year. They are working on an all new storm sewer system on the campus. The renovation of the Parker Annex into office buildings has begun.</p>

The Medicaid Reimbursement is not where we have projected. We have divided our budget meetings into Outpatient and Inpatient services and we are having meetings more frequently. Mr. Magill added that he has talked to the chairs on both sides of the assembly and they have expressed a caution in what we are requesting due to the primary repair of the roads, schools and incidences due to the flood.</p>	
<ul style="list-style-type: none"> <li>• <b>Suicide – Robert Breen, MD</b></li> </ul>	<p>Versie Bellamy introduced Dr. Breen as the next presenter on suicide. Alarming, the rate for suicide is going up both statewide and nationally. This may or may not be because of a backlash in providing anti-depressants. Dr. Breen is hoping to collaborate in the future with the USC Geography Department to provide statistics on suicide in our state and nationally. The high risk area for the state is in the upstate (Anderson and Greenville Counties). Generally in South Carolina, most women commit suicide by a lethal effort (use of a gun); however, nationally most commit by non-lethal efforts.</p>	
<p><b>OTHER ADDITIONAL COMMENTS</b></p>	<p>Dr. Evans announced that she is a new grandmother. She also acknowledged and said farewell to Christie Linguard, who has for the past year and a half been the administrative coordinator for the SC Mental Health Commission.
