Holly and Tony—While the deadline for answering or moving to dismiss the Amended Complaint is July 18, the current deadline for responding to the motion for preliminary injunction is July 8. The private defendants are going to file the attached motion to extend the time for the PI response until early August. This will allow the defendants to set forth their grounds for dismissing the entire case first. I assume you both are OK with me filing a "me too" response to this, but please confirm.

As an aside, we have been asked by SLED and DHEC to represent them as well. I've been contacted by the lawyer for the State Treasurer, but that representation has not been confirmed yet. There are still about 5 other state agencies named in the Amended Complaint that we haven't heard from.
