Good Day:

I am a United States' citizen. This letter serves to inform you that **your country has atrociously mentally and physically ABUSED me**, so I have left your country in order to protect my person. Do you care?

I have sent President Obama almost 400 letters. I am in contact with each member of the House and the Senate. I am in contact with global human rights protection agencies and will continue contact until I am no longer MUTED. I am now involving you, the state governors. To repeat: Do you care?

1. From 2012-2014, I was involved in a child custody case [Stephen Carter vs. Lily Kotila] which took place in El Cajon, California. Based on factual knowledge from the time, if anyone were to examine court documentation, the judicial system's neglect of my daughter Rose Alexandra Carter (now age 10) and me is abundantly clear.

My perspective on the court case at the time of occurrence was based on my knowledge and my extensive training at that point in time. Since that time, in attempt to make sense of my court situation, a paradigm shift occurred for me: www.livin4dtoronto.blogspot.com. **From a logical standpoint, I view my legal situation as an "either/or" scenario meaning that it is either "neglect" or the "paradigm shift."**

2. In February of 2015, I was driven in handcuffs by police to Citrus Mental Health Center in Hialeah, Florida which was prompted by a phone call from Ailema Beltran Gascon who subsequently stole approximately \$3000 from my Bank of America account. I have a Miami-Dade police record number and 5 verbal police interchanges with respect to the incident, but there has been no reprimand. For me, the issue is not theft. I care about: how did any individual have the legal right to assert such power over my body and my psyche? I care about: my body and mental violation while in the institution. I was the one who initiated a police call requesting an escort to vacate her premises as she was blockading me from exiting her residence. My voice was ignored by police, but my main point is: there was absolutely no reason for me being taken to Citrus Mental Health, let alone getting locked up for 5 days.

While in Citrus Mental Health Center, even though requested, I was shown no form of ID from anyone there other than their lapel badges. I did not know where I was? I did not know how long I was going to be trapped there? **MY PANTS WERE PULLED DOWN BY 5 MEN and I was given an injection in my buttocks.** Under the situation with variables just described, it is understandable for me to have been behaviorally and vociferously "freaking out." My reaction may have been prevented had I been interacted with using professional communication in English and shown supportive American Psychiatric Association (APA) and medical credentials. Regardless of my reaction while in hostage situation, to repeat: **WHY WAS I THERE? WHAT KIND OF SAVAGE COUNTRY ARE YOU?**

I want consequential ramifications of perpetrators for abusing my person.
