Dear Sam:

During the January 19, 2012 the Department of Disabilities and Special Needs' (DDSN) Commission meeting, the Commission approved all of the changes to the Community Supports Waiver as presented during the January 17, 2012 Public Meeting. While the changes were all approved, the Commission noted that perhaps the limits to the State Plan Services of Rehabilitative Behavioral Health Services and Durable Medical Equipment might negatively impact some Community Supports Waiver participants. Because of this, the DDSN Commission has asked that DHHS consider including Psychological Services - Counseling as an "extended state plan service" when the benefit limit under the state plan is reached, and including Durable Medical Supplies and Equipment as a service in the waiver when such items are not included under the state plan but medically necessary, in the Community Supports Waiver. DDSN is forwarding this request made by the Commission. We understand this decision rests with the Department of Health and Human Services

DDSN staff members are continuing their efforts on this renewal project and the approved changes. We appreciate your consideration of this proposal.
