


Dear Mr. Bonham:

Dear Mr. Bonham:

South Carolina Department of Health and Human Services (SCDHHS) is responding to your letter sent to Senator Lindsey Graham regarding your daughter's medication.

On October 27, 2009, we contacted Dr. Park's office and faxed the appropriate form for them to send to Medicaid to request approval for Lamictal for your daughter. After reviewing the completed form, it appears that she is not having any problems with the generic, and does not meet the criteria for the brand name. Also, according to our conversation on October 27, 2009, with Mrs. Cathy Bonham, your daughter appears to be doing well. For future reference, your doctor may submit another Medwatch Form to our Clinical Call Center and request approval for the brand name drug based on any new information that may be available.
