The affiant states that there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based on the following facts:

That on or about December 27, 2015, while at 8929 Selah St., North Charleston, in the County and State aforesaid, the above named defendant, GAYLE CHERIE HALL, did commit the offense of violation section 47-1-0040A of the South Carolina State Code of Laws, 1976 as amended, **Ill Treatment to Animals**, in that she failed to provide clean living conditions for the animals on her property and under her care.


Facts to establish this charge are that on December 27th 2015 Deputies discovered animals living in improper conditions. Multiple rabbits and cats were found to be in enclosures that contained litter boxes overflowing with feces. Many were without clean water or food. The area was not properly ventilated and a strong odor was detectable several feet from the building. The entire property was in general disarray.

The above is based on the investigation of Deputy Bates, who is a witness to prove the same against the form of the statute in such case made and provided against the peace and dignity of the State.
