Dear Governor Haley,

Challenge Obama's Anti-Gun Executive Orders
Kill Unconstitutional Gun Control Legislation, State and Federal

Whereas the Founders of America believed that our Constitution's Second Amendment protections of INDIVIDUAL LIBERTY were vital to the preservation of freedom, and

Whereas they made clear in their writings their commitment, as well, to a militia consisting of all able citizens, and

Whereas they further made clear their conviction that government's responsibility is to trust, encourage and rely upon We the People and our moral self-control, not infringe upon our God-given rights -- especially not with enforcement of unconstitutional and liberty-killing violations like "gun control" laws and illicit Executive Orders, and

Whereas we see a tyrannical, ideologically motivated Executive Branch run amok, an extreme anti-Bill of Rights, anti-Constitution and pro-internationalist Judicial Branch, and a liberal media and its Leftist clique, and

Whereas we in America today are thus threatened particularly and specifically with a loss of our Second Amendment rights, and

Whereas certain politicians in pursuit of their gun control agenda are trying to exploit tragedy from random acts of violence by madmen; in order to vitiate our God-given right of self defense and destroy the free exercise of our Second Amendment rights are promoting firearms confiscation through bills and disproportionate, unaffordable Federal taxes and regulation, and

Whereas States and Federal government, and in regulations through Bureau of Alcohol, Tobacco, Firearms and Explosives, has been caught red-handed enacting unconstitutional statutes and "re-defining" and "re-interpreting" the will of Congress in order to illicitly infringe upon the constitutionally-protected liberties of law-abiding citizens;

NOW THEREFORE, we the undersigned do declare our support for the Second Amendment that shall not be infringed. It is a defense against TYRANNY and from abuses of the Government, State and Federal. We endorse the restoration of our Founders' vision of a citizen militia empowering every capable American adult as the essential bulwark against foreign invasion, terrorism and unlawful domestic subversion and tyranny. We stand in solidarity with our fellow citizens, police and civilian, resisting UNCONSTITUTIONAL and UNLAWFUL infringement of our Second Amendment! "Civil disobedience" in the case of unconstitutional "law" is a misnomer, for such statutes are a nullity. We do specifically DEMAND our Governors respect the Constitution, and VETO any legislation that infringes our right to arms. State or Federal legislation enacted that violates our protected rights under the Constitution, such as the natural right of self defense and the right to keep and bear arms in defense of life, property and against tyranny, is a nullity and does not merit the compliance of a free and decent people. We stand on the Second Amendment of our Constitution.

Hence, it is the sworn duty of Congress and State Executives to BLOCK via veto, legislation, filibuster and all necessary means, the recent "mental health" Executive Orders of Obama that violate medical privacy rights and HIPAA and all its State-based spawn; and to HALT the unconstitutional regime of State and Federal "gun control" measures that infringe the rights of law-abiding American gun owners, and lead ineluctably to despotic firearms confiscation.
