### NH Opening Talking Points:

- THANK EVERYONE: From the local level up to the state level, all partners stepped up and did a great job throughout the winter storm.
- GIVE PURPOSE TO THE CALL: However, the purpose of this call is look back at what went right, what went wrong, and what can be done better next time.
- ASK FOR HONEST DISCUSSION AND QUICK ACTION: Nothing should be off the table at this point. Some things, I imagine we can fix quickly, and others may take time. But we're still not out of the winter weather yet, so I ask that each of you move quickly on making these changes.

## **Arthur Ravenel, Jr. Bridge**

### **Press Release**

#### **Background**

- SCDOT's preparation for inclement weather response begins long before winter hits. Each fall, every county maintenance office performs an equipment and material check to ensure SCDOT is ready for action when an inclement weather event becomes reality. This includes a review of each County's inclement weather plan to review shift staffing, road prioritization, and any new employee training needed. Our preparation also includes coordination between our headquarters and seven engineering districts, as well as local counties, municipalities, utilities, law enforcement, and the state emergency management division.
- SCDOT prioritizes routes across the state in the following order: Interstate routes, Primary routes (US & SC designated routes), and Secondary routes (farm to market roads).
- SCDOT began tracking Winter Storm Leon the previous week and crews began implementing our inclement weather plan on Monday morning in anticipation of the precipitation that was forecasted for Tuesday.
  - Preparing equipment (mounting plows, salt spreaders, and brine tanks)
  - Loading trucks & equipment with materials
  - Pre-treating major routes
- SCDOT began full crew 24-hour implementation Tuesday morning and continued to pre-treat all major routes prior to any precipitation in the state and continued rotating 12-hour shifts until the weather event was over and all road conditions were back to normal.

#### **Arthur Ravenel, Jr. Bridge**

- The Arthur Ravenel, Jr. Bridge is a unique structure in South Carolina. At completion of the Bridge in 2005, it was the longest cable-stayed bridge in North America and remains South Carolina's only cable-stayed bridge.
- This bridge has some unique characteristics listed below that limited options for ice control (i.e., not using sand or straight rock salt on the main span deck).
  - A closed drainage system much different than the normal bridge deck weep holes found on most bridges in South Carolina.
  - The bridge deck's riding surface on the main span over the shipping channel includes a 2-inch latex concrete overlay that protects the steel reinforced concrete bridge deck panels themselves.

- SCDOT began pre-treating this bridge with a brine mixture prior to any frozen precipitation falling as was done on all major routes throughout the state. However, Charleston had rain move into the area prior to the frozen participation that was detrimental to the pre-treatment activities because it diluted the brine solution.
- SCDOT is conducting an after-action review across the state regarding Winter Storm Leon, including the Arthur Ravenel, Jr. Bridge and other high level bridges in the Lowcountry.
- SCDOT is considering all options for the Ravenel Bridge to address the roadway deck itself as well as the overhead hanging ice that formed as these two issues were at the core of the bridge closures.
- Safety will remain the focus during the after action review as well as the sustainability of this unique bridge structure.
- This after action review is being conducted to derive lessons learned, coordinate options, and implement solutions in order to improve all facets of winter storm response while addressing the unique nature of the Ravenel Bridge.

**Statewide Summary** – Winter Storm Pax has begun to move into the state. Snow and sleet has been falling from the northern midlands to the upstate throughout the morning. Pavement temperatures have remained above freezing and there has been no accumulation on the pavement thus far. Precipitation is expected to taper off today and then get heavier tonight and tomorrow. SCDOT forces will be working on rotating 12-hour shifts applying salt and other anti-icing/deicing materials. Sixteen crews have been deployed from the low country to the upstate to assist with snow removal operations. Statewide, roadways are still in good shape.

Laurens County has reported minor accumulation on bridges and in some shaded areas. Newberry and Greenwood are reporting a break in the storm. The open graded surface on I-26 is holding snow and Newberry is treating/pretreating with brine. Five crews have been deployed from the low country to District 2 to assist with operations. Three crews were directed to Anderson and two crews have arrived in Laurens.

Engineering District 3 (Greenville, Oconee, Pickens and Spartanburg Counties) –Temperatures in District Three are ranging between 31 to 35 degrees. It has been snowing throughout the morning in all counties in District 3. Priority routes and bridges have been pretreated and we are continuing to treat them. Overall, pavement temperatures remain above freezing with Oconee reporting partially snow/ice covered routes in the county. All roads are reported as wet. Six crews have been deployed to District 3 to assist with operations. Three crews have been sent to Greenville and three crews to Spartanburg.

Engineering District 4 (Cherokee, Chester, Chesterfield, Fairfield, Lancaster, Union, and York Counties) – Temperatures in District Four are ranging between 30 and 35 degrees. Precipitation has been falling in many counties. Most counties are reporting road conditions as wet. Fairfield County has reported some slushy spots on I-77 that they have begun pushing. All priority routes and bridges have been pretreated. Anti-icing operations are continuing. Five crews (20 employees) from Sumter, Beaufort, and Barnwell have been deployed to Cherokee County in District 4 to assist with operations.

Engineering District 5 (Darlington, Dillon, Florence, Georgetown, Horry, Marion, Marlboro, and Williamsburg Counties) – Temperatures in District Five are ranging between 32 and 38 degrees. Freezing rain is being reported in Darlington and snow is being reported in Marlboro. Marlboro has begun treating priority routes and bridges. All other counties are reporting rain only. Road conditions are mostly wet with Dillon reporting routes being partially covered with snow/ice. Pavement temperatures are being monitored and anti-icing operations will begin as pavement temperatures warrant.

Engineering District 6 (Beaufort, Berkeley, Charleston, Colleton, Dorchester, and Jasper Counties) – Temperatures in District Six are well above freezing. Rain is being reported in most counties. Pavement conditions are reported as wet and normal. Thirteen crews have been deployed from District 6 to assist the upstate. The weather varies across the district as the front moves through. Rain is being reported in Richland and Sumter, sleet in Lexington, cloudy in Lee, and some snow in Kershaw County. Pavement is currently in good condition and is being reported as wet. Crews and equipment are actively treating and pretreating bridges and roads on a priority basis.
