Mike,

List is below, but you do a great job handling these – I think that calm patient support will win the day. I think there's value in validating the concerns of county partners and letting them know we're hearing a common chorus from the directors and that those messages are being received (to the extent that is true). We are hearing common concerns about tax status, participation in state benefit programs, indemnification for local trustees, funding consistency, some rumors about conversion to a competitive grant system, and implementation timelines.

The design of the meeting is to keep stakeholders at the table and legislators and staff around the wall in the old Wade-Hampton Governor's Conference room. This may evolve; Sen. Setzler and Rep. Erickson will likely position themselves to actively engage the conversation.

I'll do a quick introduction and we'll have Senator Fair make some opening remarks given that he originally requested the meeting. I'll take about 10 minutes describing the proposal and what we know to be open items. The remainder of the meeting will allow stakeholders listed below to ask questions and engage in a dialogue about the path forward.

If you have any guidance on this, it's welcome.
