

Dear Mr. Keck:

As you may be aware, The Joint Commission has developed a Primary Care Medical Home (PCMH) certification program that is currently available to organizations accredited under the Joint Commission's Hospital and Ambulatory Health Care Accreditation programs. I am writing to inform you of a new initiative underway at the Joint Commission for the development of a certification program for Behavioral Health Homes. This certification program will complement the Behavioral Health Care Accreditation program, and is consistent with the new health care reform efforts to improve the coordination, quality and efficiency of health services. At this time, the Joint Commission is tentatively planning a January 2014 launch date for the Behavioral Health Home certification program.

The Joint Commission is aware that many state Medicaid agencies are at different stages of considering support for Behavioral Health Home models. While some agencies are going through the process of developing their own standards for the designation of a Behavioral Health Home, other agencies will rely on external bodies, such as the Joint Commission, for an independent evaluation. If your state agency is currently developing a mechanism for designating providers as Behavioral Health Homes, we respectfully ask that you consider including the Joint Commission's Behavioral Health Home certification program as an acceptable option for providers in demonstrating compliance with the Behavioral Health Home concepts.

The standards for the Behavioral Health Home program are currently under development and will be reviewed by an external advisory group in March 2013. Once feedback has been provided by this advisory group, the draft standards will be posted on the Joint Commission's website for public comment. As a key stakeholder of this initiative, we welcome your feedback on the draft standards.
