



PROPOSED REGULATIONS
GOVERNING TANDEM TRAILER COMBINATIONS
AND OTHER LARGER VEHICLES

The concurrence of the Commission is sought in publishing Regulations 63-600 through 607, Tandem Trailer Combination and Other Larger Vehicle Access Control Act.

The proposed regulations permit truck tractors pulling twin trailers; trucks, trailers, and the other vehicles in excess of 96 inches wide, but not exceeding 102 inches wide; and truck tractor-trailer combinations greater than 60 feet in length, to operate on highways identified as the National Truck Network and other roads specifically designated by the Department. The Department will consider the need for service, economic benefits, safety, roadway capabilities, and public convenience in selecting, approving, restricting or disapproving roads as part of the South Carolina Truck Network. Application for additions of local roads to the Network may originate through local authorities. Provisions for reasonable access are proposed, to allow three miles of travel from the established Network for terminals, food, fuel, repairs and rest. Reasonable access to terminals beyond the three mile limit, and to specific Industrial, Commercial and Warehousing sites may be petitioned. Reasonable access to points of loading and unloading for purposes of local delivery is proposed for household goods carriers, auto transporters, and truck tractor-trailer combinations whose trailer length does not exceed 28½ feet. The Department may approve, disapprove, remove or restrict an addition to or portion of the Network, or access, in the overriding interest of safety, roadway capability, and public convenience.

In accordance with the Administrative Procedures Act, a drafting notice was published in the April, 1988 edition of the State Register, and a Notice of Proposed Regulation and Hearing was published in the May edition. No requests for a hearing were registered, and in accordance with procedure, a public hearing was not required.

In June 1987, a comprehensive management and performance audit of the Lowcountry Regional Transportation Authority (LRTA) was completed and presented to the Department and the LRTA Board of Directors.
