(WEST ASHLEY) On September 22, 2015, I, Deputy Haslip responded to 2317 W. Palmer Dr in reference to a Death Investigation. Upon arrival, I made contact with the complainant, A.J. McConnell, in the driveway. He told me that he came over to check on his sister, Barbara Little, after receiving a phone call from his Niece, Kimberly Little-Armstrong, to check on Barbara. He told me that he approached the front door and noticed the front doors unlocked. He then walked inside noticing blood. He then located Barbara on the bathroom floor with no pants on and blood around her body and head. He found no pulse and she was cold to the touch. At that point he called 911 and searched the house with negative contact with anyone. Barbara's daughter, Kimberly, arrived on scene. She immediately asked what was going on and tried to make her way past her uncle. At that time additional units arrived on scene. Deputy Colburn, Officer Courchesne with CPD, and I cleared the residence and found Barbara on her back in the bathroom. EMS responded to the scene and confirmed the death. Deputies secured the scene and started a Crime Scene Log. The Chaplains Office and the Coroner were contacted and responded. Sergeant Euper and Lieutenant Plunkett responded to the scene and contacted the CID supervisors along with FSU. CID and FSU arrived on scene, collected written statements from Kimberly and A.J and took over the investigation.
