Lily,

Here is some information regarding the upcoming Fireflies game on May 31. The game starts at 7:05p, but we are still waiting to hear back from them about what time the LG should arrive for the first pitch.

The game on May 31 is part of their promotional "[Wag-Along Wednesday](#)", where attendees are welcome to bring their dogs. It is loosely in conjunction with our Senior Pet Program (also sometimes referred to as Boots' Buddies). We will have a table set up on the concourse level with information on our office's programs and services.

Also, regarding the video (I tried to call your desk line earlier this morning, but your phone was on "VIP status")... I'm honestly not really sure if it's worth the LG's time to film and pay the costs for production, unless you talk with Danny, Darryl, etc. and a decision is made otherwise. The video is aired well before the game when we attended last year, and if the same crowd is present at this game, it wasn't exactly a packed

house.

Here are a few other guidelines that they sent originally:

- Minimum of three PA reads during the game (mentioning that we have a table set up)
- Any videos (optional) must be in a ".mov" format and up to but no longer than 60 seconds in length. This video must be submitted no later than one week before your specific game date.
- Name of the first pitch recipient must be turned in no later than one week before your specific game date.
- Parking will not be provided as part of the Community Organization of the Game program. (his SLED detail will have to work with stadium staff or the police department to secure a spot out front, if desired)
