Anthony McCray said that he and Quentin Inman was just riding around. Quentin Inman was on the passenger side in the front seat. Anthony McCray stopped at my residence to let me out the car. He Anthony McCray then stated out his mouth, Do you want me to wait on you to come back outside? Anthony McCray said that we meaning Anthony McCray and Quentin Inman were just riding around. I, Wendell Timmons responded and said "Let me put on something to wear. I want in the house (my residence) and put on something to wear. (Pants).

Cheryl White was already in the trunk of her Red Ford Focus dead before I went anywhere. When Anthony McCray first picked me up, Anthony McCray and Quentin Inman was already guilty of murder of Cheryl White. When Anthony McCray first stop to pick me up for a ride home, Anthony McCray was the driver of the Red Ford Focus, and already guilty of murder, before I got in the back seat

of the Red Ford Focus. Anthony McCray picked me up while on the way home with no Constitutional Rights. Anthony McCray was already guilty of murder. Anthony McCray was Unlawful Jurisdiction to D, Wendell Timmons. Marion County Sheriff Department picked up the murder. Marion County Sheriff Department arrested Anthony McCray for the murder. Anthony McCray wrote a statement saying what happened. Five names came up in the statement. Five people wrote a statement. of probation for picking up Accessories

Jurisdiction by Anthony McGray who was Already  
guilty of Murder. Unlawful procedures  
by Marion County police. Unlawful Procedures

news television showed my picture while in jail
