We have had a huge price increase in gas (at one point it was \$4.00) (also consider the insurance, and up keep of an automobile) and no one thought about those persons that provide a much need service for their local area, for patients that do not have transportation to and from the doctors office or hospital. I am sure that you are well aware of the situation in Saluda no hospital in miles and no medical transportation here, our transportation that we get comes from Edgefield County. I know that it's volunteer, yes it is but it's a service to this communities and other communities that have volunteers need. I serve on the Foster Care Review Board for this area and our mileage reimbursement is .445. I am aware that Medicaid Transportation will be contracted out someone else. Well I think until then someone should give us a mileage increase before then, because if you all don't it put the volunteer at a disadvantage to negotiate an increase with the contractor because at this present time we have been at .32 cents for maybe twenty plus years. I hope that whoever is in control and see fit to increase the mileage very soon because if you look at the situation we are long overdue.

We only want to be treated fairly and at this point we have been taken for granted. Thank you for your letter dated January 31, 2007, regarding the reimbursement rate for Non-Emergency Transportation (NET).

The NET program is in the process of transition to a NET Broker. It will be the responsibility of the Broker to establish the resources for providing transportation services to Medicaid beneficiaries and for reimbursement to providers within their system. Therefore, there are no plans to increase provider reimbursement rates for non-emergency transportation during this transition period.
