Dear Members of the General Assembly,

As the start of winter weather season approaches, please recall our state's **Winter Weather Policy for government office closings: State government offices will be closed in those counties where county government offices are closed** (i.e. state closings follow county closings). For example, if Richland County closes its offices, then state offices in Richland County will also be closed. The SC Emergency Management Division (EMD) stays in contact with all county emergency manager directors and will post state office closings on its website, [www.scemd.org](http://www.scemd.org). Information on county closings can be found by tuning into your local news station.

For any questions or requests you may have regarding preparation, response, or recovery operations for winter weather or any other emergency in your district, please contact your county emergency manager first. **Attached and included below is an updated contact list of all county emergency managers**, including their cell phone numbers.
