Thanks, again, for agreeing to speak at SCMA's Government Affairs meeting this coming Tuesday, Dec. 11th at SCMA, 1340 Bull Street on the corners of Bull and Washington Streets. I have you down to speak from 11:00am-11:30am about the Governor's legislative priorities in the upcoming session and any other issues you would like to address. As info, SCMA's main focus this session will be on:

- Workforce Development (Asking for \$6.5 million for the Technical College System to take the Manufacturing Skills Standards Council (MSSC) certificate statewide);
- Taxes (Guarding manufacturers' sales tax exemptions and waiting on the outcome of the Bodman case, manufacturing property taxes);
- Infrastructure Funding (A dedicated source of funding to maintain the state's roads and bridges);
- Unemployment Insurance System (Asking for funding to help offset the unemployment insurance (UI) tax increase that will happen again next year without it, continuing to work on eligibility reforms);
- Environment & Energy (Keeping an eye on all environmental and energy legislation that may impact manufacturers)
