Dear Mr. Fouraker,

Your Freedom of Information Act request dated September 9, 2013, was referred to me for handling. You requested "a copy of the letter sent by Senator Sheheen to Mr. Keck regarding a promotion for Chris Lykes dated October 12, 2013."

As you may know, "information of a personal nature where the public disclosure thereof would constitute unreasonable invasion of personal privacy" is exempt from disclosure under S.C. Code Ann. §30-4-40(a)(2). As to personnel records which contain evaluations, comments, health information, tax ID numbers, emergency contacts, etc., the General Assembly has specifically made some of that information available to the public in S.C. Code Ann. §§30-4-40(a)(6) (compensation or ranges of compensation), 30-4-40(a)(13) (certain employment application information) and 30-4-50(A)(1) (names, sex, race, title and dates of employment of all employees and officers of public bodies). The information that you have requested does not fall into any of the categories that have been made available to the public.
