I received your voice mail and tried to call your cell phone but I am guessing you were in transit. The State strongly urges HP not to contact OCSE to discuss a failed project audit. At this point, it is not certain OCSE will ever conduct the failed project audit. Even if OCSE does, it cannot accurately determine how much of the HP work ended up being used until it can review a near final version of the system and trace backwards through the artifacts actually used to produce that system.

The State fears HP's contact creating a problem and distraction where none currently exists.
