Austin,

Sorry it has taken me a few days to get back to you. I wanted to circle back with you on a potential DHS trip to SC to meet with key state legislators on REAL ID.

Unfortunately, as we looked at our November calendar between some previously scheduled official work travel and then some personal travel around Thanksgiving the month of November quickly gotten eaten up.

We could come down anytime during the first week of December – December 5-9. Hopefully this would be still be sufficient enough time before the state legislature convenes in January 2017.

Alternatively, if there is a desire for us to come down sooner than the first week of December, we could come down on Monday, November 14. Would just need the meeting on Monday 11/14 to be timed so that we could make the trip down to Columbia and back to DC all in 1-day. I have official travel scheduled for Chicago the next day on Tuesday 11/15 so trying to ensure I can still make my Chicago commitment. We lose the next two weeks of November to Thanksgiving and then to some other work travel the last week. And poof November is gone.

We certainly have more flexibility that first week of December, but if you desire we could make 11/14 work.
