SKIP: The Chamber will obviously not provide the information until we win the FOIA lawsuit in the lower court and then prevail in the Supreme Court. And that is going to take time. But now that we have a top-gun FOIA lawyer referred to us by SC Press Association on the case, I have no doubt we will win. And be upheld in the Supreme Court. Then we will be able to lay waste not just to the HH Chamber, but the CVBs in Charleston and Myrtle Beach -- and eventually nationwide, which as you know is my long-term goal because of my unique expertise.

That is why it's critical that we get ALL communication from the Town between them, ATAC and the Chamber, and then pore over it to make sure it matches the stuff that we already know -- and that prompted my FOIA request.

Now that several people there have finally come forward and started to talk to me and share information "on background," I am confident that the Chamber's unrelenting secrecy will soon backfire and that the consequences will be severe. In light of what we now know and have, and plan to turn over to the Attorney General's office, we will soon have Bill Miles cornered, even before the audit.

Then the audit will finish the job.

But I now have no doubt that Bill Miles will soon be held fully and publicly accountable, just as I warned him in the parking lot that night after the Bluffton Town Council meeting on February 10 -- a warning he has arrogantly ignored. And there is nothing David Tigges or anyone else can do to protect him.

As George Orwell, one of the most prophetic writers of all time and a lifelong hero of mine wrote: "In a time of universal deceit, telling the truth is a revolutionary act."

And there is no disputing the well-established fact that CVBs represent a nationwide, multi-billion-dollar web of deceit and abuse -- and that HHI Chamber represents a textbook example.
