The Boeing Co. is narrowing site proposals for the 777X work from 54 sites to a handful this week, Boeing Commercial Airplanes President and CEO Ray Conner said in a letter to employees. Boeing has not disclosed which sites are making the cut during the elimination process. Boeing plans to announce the 777X site or sites early next year.

**Note:** "Boeing is a company that we will always support. They are family. We are partners ... We always stay in talks of just making sure we're helping them to be successful, and we will continue to do that," Haley said during a visit to Daniel Island on Tuesday.

A Darlington lumber company is expanding, and the move is expected to create 50 new jobs. Canfor Southern Pine is seeing an increase in demand for their yellow pine lumber, so they're adding a second shift at the Darlington facility. It's an \$8 million investment, according to a news release from Governor Nikki Haley's office.

eterans groups joined Sen. Lindsey Graham, R-Seneca, and others on Tuesday in Washington, D.C., to urge senators not to approve a budget deal that includes about \$6 billion in cuts to retirement benefits for military retirees. Graham will hold another news conference with the veterans' groups after the U.S. Senate is expected to vote on the budget deal today. The cuts, which the senators said in a letter would reduce cost-of-living benefits for "many military retirees under age 62" by one percent, were included in the budget deal passed last week by the U.S. House with bipartisan support, including votes from Assistant Democratic Leader Jim Clyburn, D-Columbia, and U.S. Reps. Joe Wilson, R-Springdale and Tom Rice, R-Myrtle Beach.

U.S. Rep. Mark Sanford, R-S.C., said he agrees that the South Carolina Department of Health and Environmental Control should be split into two agencies that deal separately with public health and environmental regulation. Sanford, speaking during a tour of a midwife birth center in North Charleston on Wednesday, echoed similar statements made by DHEC Director Catherine Templeton this fall that the department is too unwieldy to do its job very well. "It covers so much territory in South Carolina that it becomes very difficult to deal with all the parts," Sanford said.

The college's commission will launch a nationwide search for White's successor and hopes to have a new president in place before he leaves, the school said. White started in education after retiring as a senior executive with pharmaceutical firm Ciba-Geigy. He was executive vice president of Guilford Technical Community College in Jamestown, N.C., before becoming president at Midlands Tech in 2006.

Columbia Mayor Steve Benjamin and former city employee Tony Lawton were among the original targets of what has become a broad federal public corruption investigation, a defense attorney said in federal court here Wednesday. Attorney Jim Griffin of Columbia said the FBI improperly redirected its case toward his client, Greenville businessman Jonathan Pinson, making the evidence gathered about Pinson illegal because it was gained through wiretaps aimed at Benjamin and Lawton and the city of Columbia.

Wiretap evidence can be used in the public corruption case against former South Carolina State University board chairman Jonathan Pinson and his business colleague Eric Robinson. U.S. District Judge David C. Norton also decided today that a racketeering charge against Pinson will stand. And he denied a motion made by Robinson's attorney Shaun Kent to try Robinson separately from Pinson. Kent argued that Pinson is charged with many more crimes than Robinson and that trying them together could unfairly and irreparably prejudice his client and deprive him of the right to due process.

A federal judge won't throw out wiretap evidence against a former South Carolina State University trustee. U.S. District Judge David Norton on Wednesday also denied a request by Jonathan Pinson's attorneys that a racketeering charge against him be dismissed. Pinson is accused of taking kickbacks in exchange for arranging business deals involving S.C. State. That includes trying to get the Orangeburg school to buy land from a Florida developer in exchange for a Porsche SUV as a "thank you" gift for Pinson.

The executive committee of the S.C. Republican Party has joined an already political fight against Common Core education standards. This week, the committee passed a resolution rejecting the K-12 education standards and urging state lawmakers to do the same. The resolution calls Common Core a "national scheme" that will lead to national education standards, "obliterat(ing) South Carolina's constitutional autonomy over education in English language arts and mathematics, placing control in the hands of the federal government and unaccountable private interests in Washington, D.C."

Ned Sloan, a retired Greenville construction contractor, accused Keck and the health agency of violating state law by failing to respond on time to Sloan's request for public records related to the hacking of the agency's data.

Southwest Airlines said Wednesday it is cutting its nonstop flights from Greenville-Spartanburg International Airport to Nashville. A Southwest spokesman told GreenvilleOnline.com the change is effective June 8. The cut will leave Southwest with four flights from GSP, down from seven when the airline started service to Greenville in 2011. "All of our decisions are based on customer demand," said the Southwest spokesman, Dan Landson. "With every new schedule, there's always some tweaking and adjustments here or adjustments there."

A town of Bluffton panel Wednesday night will discuss the Beaufort County School District's request to have 52 acres of property planned for a new elementary school annexed into the town. Located on Davis Road, the elementary school would house about 1,400 students from pre-kindergarten through eighth grade, and the projected construction cost is \$23,458,342. The school has a budget of \$25 million, paid for with money

set aside from a February bond issue. Right now the property is the school district's only one in the area not incorporated into Bluffton.

Former Richland County jail guard Robin Smith awaits sentencing after pleading guilty Wednesday to beating a homeless man classified as mentally ill who was handcuffed. Smith, 38, probably will be sentenced in about two months after U.S. District Court Judge Joe Anderson accepted the plea of a civil rights violation in an agreement reached with prosecutors. Prosecutors are recommending a sentence of up to two years. Anderson took the recommendation under consideration pending required pre-sentencing checks on Smith. A decision will come "two months or so down the road," the judge said.

Consumers anxious over tight insurance deadlines and lingering computer problems during the holidays will get extra time to pay their premiums under President Barack Obama's health care law, insurers announced Wednesday. The board of the industry's biggest trade group - America's Health Insurance Plans - said consumers who select a plan by Dec. 23 will now have until Jan. 10 to pay their first month's premium. That's 10 extra days beyond a New Year's Eve deadline set by the government.
