I. Presentation by Presidents of 1974-75 Appropriation Requests
for Colleges and Universities

The only item on the agenda for the October 9, 1973, meeting of the Commission was the presentations by the college and university presidents of the 1974-75 institutional appropriation requests. Prior to the first hearing Mr. Jennings presented to the Commission an analysis of all appropriation requests, a summary of which follows:
