Marilyn,

HHS says it has an investigation of South Carolina over CAPTA funded plans of safe care for substance-exposed newborns. SC was the only state HHS cited in a letter to Congress that committee chairman Rep. Kline released today. I've attached the letter. Here's the excerpt:

Most recently, ACF investigated South Carolina after becoming aware that the state is not properly implementing the CAPTA-required plans of safe care for substance-exposed newborns. ACF has sent a letter to the state and made contact with officials to discuss and verify the facts of the situation. ACF is now in the process of placing South Carolina on a PIP to address the important CAPTA requirements. As we do when any state is placed on a PIP, we plan to work closely with the state's leadership, providing the necessary technical assistance to support the state as they implement the appropriate policies and practices.

Could we talk by noon EST to review this and get any details or explanation the state could provide? What's going on?

It's a story on deadline because of a congressional hearing on CAPTA this morning.
