Attorney Arthur Schulcz, who fought Navy bias against evangelical Christians, examines Supreme Court nominee

Judge Kavanaugh's bias in cases that have come before him and how he defers to the hierarchy of the Catholic Church.

"He protected Catholics against a clearly illegal system" of promoting chaplains in the Navy, Schulcz explains. In doing so,

he adds, Kavanaugh's rulings have violated the constitutional prohibition on the establishment of a state religion. Yet,

Republicans and Democrats on Capitol Hill don't want to touch the issue, in the same way they ignore Kavanaugh's role

in the ultimate Clinton cover-up - the murder of Clinton White House lawyer Vincent Foster.

Personally, I neither endorse nor oppose Judge Brett Kavanaugh for Supreme Court.

But this week, as Judge Kavanaugh faces the Senate Judiciary Committee, I received an alarming email from a lawyer

I know in DC who appeared 3 times before Judge Kavanaugh's courts, arguing for Navy Chaplains' religious freedom.

Unfortunately [Judge Kavanaugh ruled against Evangelical and Pentecostal Chaplains who pray in Jesus' name](#).

The lawyer for 65 chaplains suing the Navy writes:

"Judge Kavanaugh authored one opinion and his failure to dissent or concur signified his approval with the decision and its judicial philosophy in the other published opinion. Every decision has been a

constitutional disaster that now has made it very difficult, almost impossible, for chaplains to challenge both subtle and overt religious preferences.

He has participated in changing well-established First Amendment and Establishment Clause precedent. His decisions are one reason the case is in the 19th year and we just lost on summary judgment despite evidence showing 38 years of denominational preference which included at least one Catholic with the power to destroy any candidate on every promotion board for 54 years.

"His decisions have protected [and **avored**] **Catholics** who statistics show have been the Navy's preferred denomination **[over evangelicals and Pentecostals]** until after we filed suit; he ignored a promotion voting procedure that allows one board member to anonymously destroy a promotion candidate's career, i.e., career assassination with no accountability. The ability of one chaplain board member to do so is documented by the Naval Inspector General and yet Judge Kavanaugh ignored it to dismiss our appeal..."

"Judge Kavanaugh's other panels display a similar hostility to evangelicals and military personnel and fail to apply law and precedent even-handedly. In re Navy Chaplaincy, 738 F.3d 425 (D.C. Cir. 2013), subsequently (1) changed the chaplains' denominational preference claim to a 'disparate treatment' claim they did not make which he then denied for failure to show specific intent to discriminate; (2) denied a challenge to CHC promotion procedures that for 38 years produced consistently higher promotion rates for Catholic chaplains not explainable by chance when compared with plaintiffs' denominations; (3) requires evidence of intent to prove a denominational preference claim; and (4) ignored evidence one selection board member anonymously voting 'zero' could and has destroyed chaplains career contrary to well-settled law."

Furthermore, my recent TV interview with Philip Jauregui of the Judicial Action Group confirms that some conservatives have

concerns that cause them to oppose Kavanaugh.

"Opening statements by Judiciary Committee members and the nominee will occur on Tuesday, September 4.

The questioning of Judge Kavanaugh will begin on Wednesday, September 5.

"This announcement comes after the committee has received the **largest number of Executive Branch records ever** for the consideration of a Supreme Court nominee. "The committee also expects to receive hundreds of thousands of additional pages of Executive Branch documents.

These records will be reviewed in addition to the 307 cases in which Judge Kavanaugh wrote an opinion as an appeals court judge, the hundreds more opinions he joined, and the more than 17,500 pages of material he provided in response to the committee's bipartisan questionnaire."
