We greatly appreciate all of your feedback, energy, and enthusiasm. We also want to thank you for your willingness to help take part in such a large-scale, statewide donation of food items from many generous individuals and companies with roots right here in South Carolina.

For those of you who order and receive delivered meals through a caterer: We have determined that it will be most efficient -- for both the ordering process and the transportation of food -- for us to partner directly with various caterers to prepare and transport the donated goods. We have already coordinated and arranged delivery through these caterers and ask that you **please submit your orders for the Wednesday, November 26 meal through your**

normal ordering process. The various distribution points have been very helpful in working with us to incorporate these donated goods into their existing supplies of food.

For those areas that prepare and distribute your own meals without using a caterer: You have already been contacted to discuss food items available, quantity, and general details regarding food delivery. However, if you have any questions, please call us at 803-734-2080.
