In the time of Kieth Nelson having temporarily of his daughter Layanna he went to jail for possession of marijuana and orderly conduct. Mrs Hunter knew this and still allowed my baby girl remain in a drug inviroment in the home of her father and his girlfriend. Michelle is abusing Narcotics, Kieth is to and using marijuana. Mrs. Hunter literally waited 5 months to start my treatment plan, My lawyer requested a court hearing asking for my children to be placed back ~~and~~ with me since they were taking there time on getting my plan started, month before court then thats when they started getting things done w/ the treatment plan.

They knew I had 6 months to complete it and they still lag behind on there job. When we went to court Sept. 30<sup>th</sup> my lawyer Ernest Spong Mrs. Hunter was caught in so many lies under Oath. Now that the case has been closed, its been a month and I still yet have my court papers. In the process I have ask Kieth and Michelle to see my daughter. Thank you, I hope you find it in your heart to help me. Please Look into these matters.

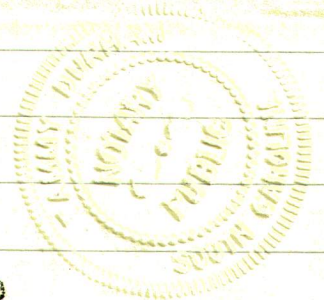
