**Regarding: UPDATE: Top Secret Special Access Program AQAC & BAK**

Dear Mr. Clapper:

As some background, I previously worked for Parsons (a major federal contractor) and was involved in top-level technology at the company. My first day on the job was September 10, 2001. We all know what happened the next day. After some disagreements over some issues, I left Parsons but have continued to be involved in a SAP based on psychotronics (SAP designation may be AQAC or BAK). Dear Congressman Schiff:

Thank you for the letter denying assistance regarding a matter that I believe is in the purview of the House Intelligence Committee. As quoted from the website: "The United States House Permanent Select Committee on Intelligence (HPSCI) is a committee of the United States House of Representatives, currently chaired by U.S. Congressman Devin Nunes (California). The HPSCI is charged with the oversight of the United States Intelligence Community, which includes the intelligence and intelligence related activities of 17 elements of the US Government, and the Military Intelligence Program."
