This is in response to your two recent requests for information from the South Carolina Department of Health and Human Services (DHHS) pursuant to the South Carolina Freedom of Information Act (FOIA). Your requests, both dated April 30, 2010, were received in our Office of Human Resources on May 4, 2010.

In one of your letters, you request "information regarding employees' names, addresses and their employment status of any and all full or part-time employees, who are currently participating in the South Carolina Deferred Compensation Program who work in Richland, Lexington, and Newberry counties and who were born prior to January 1, 1956." In your other letter, in addition to the current employment status and names of all DHHS full time employees, you request "any and all names of persons who as of January 1, 2010 had 27 years or more of service with your agency or a combination of state services totaling 27 years or more of service and who work in Richland, Lexington, or Newberry counties. Also, please indicate which employees participate in the TERI program."

Pursuant to S.C. Code Section 30-4-50, certain matters have been declared public information. These matters are:

- (1) the names, sex, race, title, and dates of employment of all employees and officers of public bodies;
- (2) administrative staff manuals and instructions to staff that affect a member of the public;
- (3) final opinions, including concurring and dissenting opinions, as well as orders, made in the adjudication of cases;
- (4) those statements of policy and interpretations of policy, statute, and the Constitution which have been adopted by the public body;
- (5) written planning policies and goals and final planning decisions;
- (6) information in or taken from any account, voucher, or contract dealing with the receipt or expenditure of public or other funds by public bodies;
- (7) the minutes of all proceedings of all public bodies and all votes at such proceedings, with the exception of all such minutes and votes taken at meetings closed to the public pursuant to Section 30-4-70;


