1. Governor's Savannah River Committee- just need your current list of members
2. Medical Disciplinary Commission of the State Board of Medical Examiners- looking for a list of members
3. Pee Dee Tourism Commission- just need your current list of members to compare with ours- looks like we have most of the information, but I want to make sure since there are some we don't have
4. SC Commission on National and Community Service (ex. Order 2007-24)- do you have any membership info on this? Looks like it may be mostly through United Way at this point, but I'm kind of unclear on that
5. State Historical Records Advisory Board- Archives indicated that it is no longer active due to lack of funding. Can you confirm?
6. State Human Affairs Commission- the list of members we have doesn't really line up with statute so I wanted to compare with your list of members. It may just be holdovers from before the addition of the 7th district, but I'm not sure
7. Accountability Strategy for the South Carolina Prevention Programs Review Panel- no clue what this is. Any thoughts?
8. Advisory Committee to the State Board of Cosmetology- we don't have any membership info, at least nothing recent.
9. Governor's Mathematics and Science Advisory Board- is this still a board? I'm not sure what statute/act/order created it either.
10. Hazardous Waste Management Select Oversight Committee- the Governor just has a few appointments to this one. Do you know who they are?
11. Job Training Council- does this still exist? Or maybe it is now under a different name? I can't really find anything on it.
12. Local Government Study Committee (2-35-10)- the Governor has a few appointments on this one. Do you know who they are? Is this still an active committee?
13. Medical Advisory Panel (42-11-170)- appointed by the Governor. Still active? If so, do you have a list of members?
14. Military Assistance Council (ex. Order 1999-34)- is this still active? If so, do you have a list of members?
15. Race Relations Commission- created by Gov. Beasley by executive order. I'm guessing this is inactive- can you confirm or correct me on that?
16. Commission on Disabilities and Special Needs (44-20-210)- we have the current board info. However, we have an at large member and I thought it should just have one member per district. Maybe the AL member is from before the shift to 7 districts?
17. SC Rural Water and Sewer Act Advisory Committee (6-19-30)- we don't have any info beyond what's in the statute. Still active? If so, any membership info?
18. Southern Regional Education Board (Act 60, 1948)- just need current members
19. Southern Regional Task Force on Child Care- I don't know anything on this one, so do and know if it is still active, and if so who members are, please let me know!
20. State Advisory Council on erosion and sediment reduction (48-18-50)- still active? I don't think we have any membership info.
21. State Interagency Planning and Evaluation Advisory Committee (1-25-60)- the Governor only appears to have one appointment on this one, but I thought I'd add it in case you know anything about it. I haven't been able to find membership info.
22. Statewide Health Coordinating Council (44-5-50)- is there a certain number of members? Can you send

me a list of members as you have it? I'm not seeing much on this one, so I'm not sure if it is still active or not.

23. Governor's Council on Physical Fitness-do you show any members? If so, what are their terms.
