
The Coroner is an important role in the specialty of forensic science which requires independent and autonomous investigations, apart from, yet side by side, law enforcement. There must be a clear distinction between a law enforcement investigation and a coroner investigation, as there are times when

the Coroner must make tough rulings that law enforcement may or may not agree with. The Coroner must be independent. The case of Walter Scott here in Charleston County and the current case of Tabetha Grooms in Dorchester County are two recent examples. At the same time the Coroner must be able to truthfully and compassionately assist survivors after a tragic death such as we saw here in Charleston County with the shooting at the Mother Emmanuel Church. I fondly remember when Alice Durr volunteered and then came to the Charleston County Coroner's Office 10 years ago, to man our office so all of the staff of the Charleston County Coroner's Office would be able to attend the funeral of the Charleston 9, the nine firemen who tragically lost their lives in the Sofa Super Store fire.

It is my sincere belief that Chief Deputy Coroner Alice Durr is the appropriate candidate to be appointed Interim Dorchester County Coroner as she has the right investigative, office management and budget experience to continue the uninterrupted day to day operation of the Dorchester County Coroner's Office.
