**Aiken Standard:** House approves MOX construction funding

The United States House showed support for the Savannah River Site's MOX program on Thursday by green-lighting its version of the National Defense Authorization Bill.

**Note:** "Providing funding to finish the construction of the MOX facility is not just about holding the Obama administration accountable for their legal responsibilities; it's about doing what is best for South Carolina – which is why Governor Haley has fought alongside our federal delegation to ensure that it happens," said spokesman Doug Mayer. "Today, the House took a big step in the right direction and now it's time for the Senate to do the same."

The S.C. House took a decisive step Wednesday toward clearing up and strengthening the laws designed to ensure that the state's elected officials conduct their jobs ethically. The bill has substance, and its approval by a vote of 110-0 is encouraging.

The House Ethics Committee on Thursday ordered Rep. Harold Mitchell to pay a \$16,100 fine and reimburse his campaign account nearly \$7,400 for improper expenses.
