State law requires board and commission members to complete the training and certification program within eighteen months of appointment or reappointment. If a member does not fulfill the training and certification program requirements, the Governor is required to notify and remove the member from the board unless the member is granted an extension to complete the training based upon exceptional circumstances.

The Governor's Office plans to send letters to commission members who are not compliant with the training and certification program during the first week of September. Directors: please share this information with your commission members.
