Hi Nicole,

We are delighted that the Governor will be able to join us on May 3rd to raise awareness of the ongoing need for donations to the One SC Fund. That time will work with us and we will add it to our media advisory going out on Monday to help encourage media to be in attendance. As far as what she will be doing, here are our thoughts:

Two generous donors are supporting the One SC fund through Midlands Gives. The Cheerful Giver will donate \$1 to the One SC fund for every donation made to any of the 375+ nonprofits participating in Midlands Gives. And, the Lipscomb Family Foundation will match all donations, up to \$10,000, made to the One SC fund through Midlands Gives. If media is there, we would like the Governor to talk to them about Lipscomb Family Challenge and the Cheerful Giver Match.

In order to maximize the Cheerful Giver match, we would also like to escort the Governor to two or three nonprofits that are participating in our Spirit Communication Park Nonprofit Marketplace for a meet & greet

and photo op for her social media accounts. It would be great if the Governor could post about being at the park, talking about the importance of philanthropy and encouraging people to give because each gift adds a \$1 to the One SC Fund.

We noticed that the Original Six Foundation has supported causes that impact education and literacy. Looking at the nonprofit marketplace list, we thought the following nonprofits might interest her. We will let her select which ones she would like to meet. If she would like to see the entire list, we would be happy to provide it.
