Shepherds [?] at First Presbyterian Church:

Once again I write the pastors and elders of First Presbyterian Church, asking you to uphold the Doctrine of **Biblical Separation** from Unbelievers ( e.g., 2 Corinthians 6:14-18, **KJV** ); and practice consistent with the position of The Westminster Confession of Faith regarding the un-Biblical, **false religion** of Roman Catholicism.

Specifically, concerning the repeated role of Mark Baumgartner, a church officer (previously a Deacon; then after one term of service, now an Elder) of First Presbyterian Church, A.R.P., as the Columbia campaign leader of the Roman Catholic-led, national and international (so-called) "40 Days for Life" ecumenical prayer campaign, which Mark Baumgartner conducts outside the Planned Parenthood child-killing center in Middleburg Park. I ask you to judge whether this conduct is consistent with God's Second Commandment of the Ten, as expressed in detail in **The Westminster Larger Catechism** ( Questions #107, #108, #109, #110 ), especially for a church officer.

I wrote about this matter previously in 2017. Now, at least the top six Headquarters Team members of "40 Days for Life" are Roman Catholic. The President / CEO is a Knight of Columbus ( the Knights of Columbus, loyal to Rome's Papacy, seek to make America more Roman Catholic for the Vatican ). The General Counsel / Chairman of the Board is Jesuit-educated ( Jesuits are the leaders of the ongoing Roman Catholic Counter-Reformation to destroy the effects of the Reformation, a major stratagem and tool of which today is Ecumenism, inviting Protestants and Baptists and Evangelicals to "yoke up" with Roman Catholics in various culture war causes [ e.g., **The Manhattan Declaration** **ecumenical abomination** ] ). Many of the Roman Catholics who come to "pray" outside the Planned Parenthood "abortion" center in Middleburg Park, "pray" the blasphemous, idolatrous "Rosary", often with other Roman Catholics, giving worship and "prayer" to the Roman false mediatrix known as "Mary" ( a.k.a. the queen of heaven – Jeremiah 7:18, Jeremiah 44:15-25, **KJV** ), in direct disobedience to the revelation of Scripture, e.g.:

"For there is one God, and one mediator between God and men, the man Christ Jesus." 1 Timothy 2:5, **KJV**

On Saturday, September 29 at the opening "rally" for the Columbia, SC "40 Days for Life" campaign, ecumenical group

prayer, Roman Catholics and Protestants together, was led by Mark Baumgartner, and also by an Elder from another church outside the Planned Parenthood "abortion" center; however the false "Jesus" of Rome is not the true Jesus.

Furthermore, instead of moving in the direction of reform and obedience to God's Word, Mark Baumgartner has moved in the opposite direction, toward further entrenchment and involvement with this Romish / ecumenical campaign. Just this past July, about three months ago, Mark Baumgartner went to Phoenix, Arizona to participate in the "40 Days for Life Leader Symposium". The keynote speaker was Roman Catholic Bishop Thomas Olmstead, Bishop of the Roman Catholic Diocese of Phoenix. Olmstead lived 16 years in Rome, Italy, obtained a master's degree and doctorate, and worked more than nine years in the Vatican Secretariat of State. How likely indeed is it this Pope-appointed Roman Catholic bishop understands the Vatican plan to Romanize the United States? Enclosed with this letter are screen shots of various "40 Days for Life" websites and facebook pages, as well as an article from "The Catholic Sun" ( serving the [ Roman Catholic ] Diocese of Phoenix ), and selected pages from the Phoenix, Arizona "40 Days for Life Leader Symposium" event program.

However, I return to the subject line of this letter: FALSE SHEPHERDING AT FIRST PRESBYTERIAN CHURCH (Ezekiel, chapter 34, [KJV](#)), and this specific question: "Why is an Elder at First Presbyterian Church serving locally as a leader of a prayer campaign which is led nationally and internationally by Roman Catholics, and endorsed by the JESUIT Pope ? – moreover, what does this say about the First Presbyterian Church Pastoral and Session oversight ?" The issue is not only that Mark Baumgartner is repeatedly leading a local ecumenical prayer campaign led nationally and internationally by Roman Catholics, but the larger issue is, why are the pastors and Session allowing him to do so ? Where are the shepherds ?

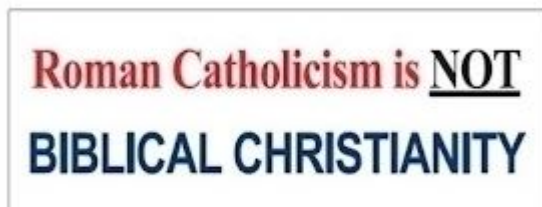

### Separated Unto the Gospel

Come out from among them, and be ye separate, saith the Lord, and touch not the unclean thing;

and I will receive you, and will be a Father unto you, and ye shall be my sons and daughters, saith the Lord Almighty. Having therefore these promises, dearly beloved, let us cleanse ourselves

never choose them for friends. We must not defile ourselves by conversing with those who defile

themselves with sin. Come out from the workers of iniquity, and separate from their vain and sinful

pleasures and pursuits; from all conformity to the corruptions of this present evil world. If it be

an

envied privilege to be the son or daughter of an earthly prince, who can express the dignity and

happiness of being sons and daughters of the Almighty? [ emphasis added ]
